**4.0 TERM OF ENGAGEMENT**



**Fifth Phase Submission**                      **Wednesday, October 30, 2019 to Friday, November 29, 2019**


All other requirements and provision of RFQ-004-2019-DR-STT/STX, General Construction Contractor, shall remain in full force and effort.
