## PROFESSIONAL SERVICES CONTRACT

This CONTRACT (hereinafter referred to as the "Contract") is made this 23 day of October, 2019, in the Territory of the United States Virgin Islands, by and between the VIRGIN ISLANDS HOUSING FINANCE AUTHORITY, a body corporate and politic constituting a public corporation and autonomous governmental instrumentality of the Government of the United States Virgin Islands, whose address is 3202 Demarara Plaza, Suite 200, St. Thomas, U.S. Virgin Islands 00802-6447 (hereinafter referred to as "VIHFA") and Armand Corporation, a foreign corporation registered to do business in the U.S. Virgin Islands, whose address is 1350 Broadway, Suite 1901, New York, NY 10018 (hereinafter referred to as the "Contractor"). Contractor and the VIHFA may sometimes hereinafter be collectively referred to as the "Parties" and individually as a "Party."

## WITNESSETH:

WHEREAS, on September 6, 2017 and on September 19, 2017 Hurricane Irma and Maria (the "2017 disasters") had a devastating impact on the United States Virgin Islands and caused significant destruction to housing, infrastructure, and the economy; and

WHEREAS, as a result of the 2017 disasters, the Government of the Virgin Islands designated the VIHFA as the lead agency for administering the Community Development Block Grant Disaster Recovery ("CDBG-DR"), which is authorized under the Additional Supplemental Appropriations for Disaster Relief Requirements Act of No. 2017, Public Law (P.L.) 115-56, and the Further Additional Supplemental Appropriations for Disaster Relief Requirements Act of 2018, P.L. 115-123; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) awarded $\$ 1,863,742,000.00$ of CDBG-DR funds to the U.S. Virgin Islands in two separate Tranches. Tranche 1 in the amount of $\$ 242,684,000$ was announced on February 2, 2018, and Tranche 2 in the amount of $\$ 779,217,000$ was announced on April 10, 2018.; and

WHEREAS, under Public Law (P.L.) 115-56, and the Further Additional Supplemental Appropriations for Disaster Relief Requirements Act of 2018, P.L. 115-123, HUD awarded CDBG-DR funds to be used to address unmet needs from the 2017 disasters; and

WHEREAS, on April 5, 2019 the VIHFA issued a Request for Proposals, RFP 003-2019-DR-STT/STX to solicit proposals from qualified and licensed firms to provide construction management services for the VIHFA's CDBG-DR funded programs; and

WHEREAS, the Contractor submitted a proposal which VIHFA has accepted; and
WHEREAS, VIHFA selected the Contractor to provide construction management services for its portfolio of housing programs under the CDBG-DR Program, as shown in the scope of work set forth in Section I of the Contract; and

WHEREAS, the Contractor by its acceptance of the terms and conditions of this Contract is willing and capable to provide the services contemplated under this Contract; and

WHEREAS, the VIHFA desires to enter into an agreement with the Contractor to perform construction management services for its portfolio of housing programs under the CDBG-DR Program;

NOW, THEREFORE, in consideration of the mutual covenants herein contained, and intending to be legally bound by this written instrument, the parties hereto do covenant and agree as follows:

## 1. SCOPE OF WORK:

Contractor shall provide Construction Management Services for the DR Housing Programs (which includes, but may not be limited to, Disaster Recovery (CDBG-DR) Homeowner Rehabilitation and Reconstruction Program and the CDBG-DR Rental Rehabilitation and Reconstruction Program, the Contractor shall perform, or cause to be performed, the following services:
a) Enhance the capacity of VIHFA to oversee a large volume of construction projects efficiently and in compliance with all federal, state and local laws, rules, and regulations governing CDBG-DR funding, and local building codes;
b) Provide high quality housing rehabilitation and reconstruction consistent with Program policies and procedures and all applicable requirements;
c) Recommend revisions to program policies, procedures and operations based on expertise and experience in the Program
d) Respond promptly to inquiries, schedule site visits and inspections, within program guidelines
e) Attempt to detect and prevent fraud, waste, and abuse
f) Ensure continual quality assurance/quality control
g) Assume control and management responsibility of current programming and procedures
h) Assist in the permitting process and resolution of regulatory issues
i) Provide daily and periodic communication/reports, to include homeowner construction files, inspection reports, to VIHFA/Case Manager program staff
j) Secure documentation of construction activity to provide an audit trail of all applicants through final inspection and closeout
k) Maintain an ability to provide services in multiple languages as necessary, including English and Spanish

## Construction Management General Standards:

## Program Design

a) Adhere to construction standards appropriate for USVI rehabilitation and reconstruction activity, including customization of green building requirements and resilience measures to meet the needs of USVI housing stock
b) Develop standard specifications and cost schedules
c) Conduct damage assessments and prepare detailed scopes of work and cost estimates for specific projects
d) Recommend ways to organize construction projects, including grouping sites together, to achieve efficiencies and cost savings in construction
e) Conduct progress inspections and review contractor requests for payment to VIHFA
f) Conduct final inspections to ensure quality construction, and compliance with all applicable codes, regulations, and program requirements to support project closeout

## Program Administration:

a) Assist VIHFA in serving as on-site project management representative for completion of construction items for the construction projects
b) Assist and work with VIHFA to perform Value Engineering Analysis and Constructability Reviews of the design and contract documents to identify savings opportunities, discrepancies and variances prior to bid of Work
c) Develop detailed final cost estimates for each project and validate against established Program budget, as agreed to by the Parties
d) Assist in the preparation and packaging of construction bid documents, project specific special conditions including, but not limited to, mitigation monitoring plan, contract time, construction phasing, completion and occupancy dates
e) Provide recurring administrative reports pertaining to construction projects
f) Develop timelines/network that will incorporate all activities relevant to the project, including priorities and critical milestones
g) Assist VIHFA in its community relations efforts to generate local contractor participation in the Program and provide information relative to upcoming projects to the local contractor community

h) Assist VIHFA in establishing a standardized bidding process and procedure
i) Assist VIHFA in the preparation and issuance of Notice of Award and Notice to Proceed
j) Coordinate and conduct project pre-construction conferences
k) Assist VIHFA in working with other consultants and contractors during the construction administration phase of the project(s)
I) Maintain documentation in shared projects files that include design documents, constructability review comments, estimates, bid documents, contracts, submittals, permits, meeting minutes, correspondence, change orders, pay requests, RFIs, shop drawings, claims, schedules and closeout
m) Perform facility inspections, identifies deficiencies and initiates corrective actions
n) Assist VIHFA to manage, evaluate and mitigate all change order proposals and schedule delays
o) Monitor and report on contractor's quality control
p) Attend job-site progress meetings, prepare and distribute meeting minutes and report urgent issues
q) Develop and maintain a detailed project schedule and review and report on contractor's baseline schedule and schedule-of-values
r) Review Contractor's periodic schedule updates and review invoices to VIHFA
s) Assist in development of the transition plan to occupy the premises upon completion of construction; develop and implement the phasing and synchronization of transition activities, as required
t) Perform analysis of equipment failures and outages to identify trends and areas needing improvement
u) Make recommendations to VIHFA regarding final project approval and acceptance; receive and review project(s) record and as-built drawings; assist in preparing and submit the project(s) accounting and close-out reports

## Architectural \& Engineering Blueprints:

a) Assist VIHFA in obtaining architectural and engineering blueprints, on an as needed basis, within scope of agreement with architect. VIHFA has agreed to and desires that Boschulte Architecture be engaged as the architectural and engineer for the project.
b)Provide Field verification inspections
c) Assist in obtaining Building Permits for plans and, if required, submit to the Department of Historic Preservation if required
d) Submission of demolition permits to Department of Planning and Natural Resources
e) Perform other related duties as assigned within the scope of construction management services, as defined by VIHFA

## Damage Assessment Services:

a) completion of damage assessments using software which has been approved by the program, price lists, procedures, forms in accordance with program policies
b) Complete an assessor's checklist for each damaged property that includes site assessment, evaluation of damage, structure condition and recommendation of repairs
c) Provide a damage assessment statement on the assessed structures condition, safety and rehabilitation/repair/reconstruction course of action
d) Recommend to VIHFA the categorization of damaged properties into one of the many available programs for housing assistance and recovery in accordance with the United States Virgin Islands CDBG Action Plan (e.g., repair, reconstruction, substantially damaged, nonsubstantially damaged, etc.)
e) Provide a description of the damage, and define scope of work and photographic documentation in accordance with approved procedures

## Inspection Services:

a) Provide inspection related project management services for interim inspections, final inspections and scope verification inspections

Provide inspection(s) to ensure compliance with the VIHFA Green Building Retrofit Checklist and other applicable Green Building requirements
c) Verify scope of work is consistent with the approved design documents and Estimated Cost of Repair (ECR) and Allowable Activities (AA) documents
d) Track and maintain a record of change orders, budgets and expenditures for all contracts for projects
e) Track, monitor schedules, provide recommendations and implement strategies to keep projects on schedule and within budget as necessary

## Close-out Services:

a) Coordinate with VIHFA staff and team of consultants to ensure timely close-out of projects
b) Assist VIHFA to gather and assemble all financial, programmatic and administrative documents related to close-out.
c) Close out procedures to occur upon scope of work completion of each home and/or project

## 2. TERM:

(a) This Contract shall begin on the 23 rd day of October, 2019, or the date on which the last Party has signed the Contract, whichever is later (the "Effective Date") and shall end on the date that is two (2) years after the Effective Date.
(b) The VIHFA may elect to exercise the option for an additional two (2) year term, subject to Contractor's satisfactory performance. VIHFA will exercise this option by providing Contractor written notice no less than sixty (60) days prior to the expiration of the first contract term.

## 3. COMPENSATION:

(c) VIHFA, in consideration of satisfactory performance of the services described above, shall pay the Contractor as compensation for the services rendered under this Contract an amount not to exceed Thirteen Million Five Hundred Thousand Dollars ( $\$ 13,500,000.00$ ) (the "NTE"). Contractor shall submit invoices for work performed that conform to the Project Schedule as outlined in Appendix A.
(d) It is expressly understood and agreed that in no event shall the amounts to be paid by the VIHFA to the Contractor under this Contract exceed the rates and conditions made a part of this Contract unless expressly agreed to in writing.
(e) Contractor's obligations under this Contract and VIHFA's obligation to pay the Contractor for services performed under this Contract are contingent upon the availability of applicable disaster recovery funds. VIHFA shall be the final authority as to the availability of funds for this Contract and as to what constitutes "applicable funding" to complete this Contract. If any such funds are not made available for the Contract purpose, such event will not constitute a default by VIHFA, but shall entitle Contractor to terminate if funds are not received and available to compensate Contractor for any period exceeding thirty (30) days. Notwithstanding the foregoing, Contractor shall be paid for all costs and services incurred to the date of any such notification from HUD to VIHFA regarding the non-availability of applicable disaster recovery funds. Payment for services rendered under this Contract to be paid is not eligible for reimbursement from any other funding source.

## 4. REPRESENTATIONS, WARRANTIES, AND COVENANTS BY CONTRACTOR:

The Contractor represents, warrants, and covenants as follows:
(a) Contractor is a foreign limited liability company registered to do business in the U.S. Virgin Islands.
(b) Contractor will, during the term of this Contract, remain engaged in the business of providing construction management services and Contractor remain in good standing and qualified to do business under the laws of the Territory, including maintenance at all times of a valid V.I. business license.
(c) Contractor will not cease doing business, dissolve or otherwise dispose of all or substantially all of Contractor's assets and will not voluntarily consolidate with or merge into any other entity or permit one or more other entities to consolidate with or merge into Contractor.
(d) Contractor has the power to execute, deliver and perform, and enter into the transactions contemplated by this Agreement, and has duly authorized the execution, delivery, and performance of this Agreement.
(e) The execution and delivery of this Agreement, the consummation of the transaction contemplated hereby and the fulfillment or compliance with the terms and conditions of this Agreement do not and will not conflict with or result in a breach of any of the terms, conditions, or provisions of any legal restrictions or any agreement or instrument to which the Contractor is now a party or by which Contractor is bound or constitute a default under any of the foregoing.
(f) No information, statement, or report furnished in writing by the Contractor in connection with the negotiation of, or performance under, this Agreement and the consummation of the transactions contemplated hereby, contains any material misstatement of fact or omits to state a material fact that would make the information, statement or report misleading.
(g) That Contractor has obtained all the applicable licenses or permits, temporary or otherwise, as required by Title 27 of the Virgin Islands Code; and familiarized itself with the applicable provisions of Title 27 of the Virgin Islands Code pertaining to professions and occupations.

## 5. CONTRACTOR RESPONSIBILITY:

(a) Contractor shall supervise and direct the work of its employees and those subcontractors that are specifically engaged to assist in the completion of Contractor's work under this Contract.
(b) Contractor shall maintain the professional standards applicable to its profession.

(c) Unless otherwise specified in this Contract, the Contractor will provide for and/or pay for all labor, materials, equipment, tools, machinery, transportation, and other goods, facilities, and services necessary for the proper execution and completion of Contractor's work in this Contract. Without limiting the foregoing, Contractor is not responsible for payments to any other provider of construction services, any trades providing work or materials for the projects, or professionals' compensation.

## 6. PAYMENT PROCESS:

a. Invoices shall be submitted on a monthly basis.
b. Compensation shall be invoiced as outlined in Appendix B. Full or partial payment will be made upon satisfactory completion of each invoice as accepted by the Project Manager. VIHFA will notify Contractor of any disputed charges as soon as possible but no later than fifteen (15) days.
c. Indemnification: Should the Contractor, after receipt of payment of invoices from the VIHFA fail to pay in a timely manner all persons who have fulfilled their obligations to perform labor and/or furnish materials in the prosecution of the work provided for herein, including by way of example Contractor's employees, subcontractors and furnishers of materials, machinery, equipment and fixtures, then Contractor agrees to indemnify VIHFA for said payment(s). Timely payments from Contractor to its Subcontractors and Vendors shall mean within three (3) business days of receiving payment from VIHFA.
d. In the event that performance standards required herein are not being met by the contractor, VIHFA will notify the Contractor in writing of such performance deficiencies. Upon receipt of a written letter, the contractor would be required to prepare and submit a proposal to VIHFA outlining ways to correct the problem and improve service. Once the proposal is submitted and accepted by the VIHFA, the contractor would have thirty (30) days to improve its performance.
e. If VIHFA does not issue a payment of an invoice, through no fault of the Contractor, within fifteen (15) days after the date established in the Contract, the Contractor may, upon three additional days' notice to VIHFA, stop the Work until payment of the amount owing has been received.

## 7. AMENDMENTS:

(a) The VIHFA may transmit to Contractor written notice requesting changes VIHFA believes are within the scope of services of this Contract, which may include additions or expansion of the contracted services for Contractor's written approval. VIHFA may also amend this Contract to conform with federal, state, or local governmental guidelines, policies, and available funding amounts, or for other reasons which amendment shall be submitted for Contractor's written approval.

(b) The Contractor may submit to the VIHFA a request for a change in the scope of work under this Contract, or additional compensation and adjustment to the NTE. The Contractor will prepare a detailed written description of the change request and a proposed price of making such change. . If VIHFA does not agree with the need for the change or with the Contractor's proposed price, VIHFA reserves the right to decline its acceptance with no cost obligation incurred. If VIHFA agrees to the change, VIHFA will negotiate with the Contractor and agree to a firm fixed price for the change. The Contractor will not be authorized to proceed until a properly executed amendment is in place.
(c) Amendments to this Contract must be in writing and must be signed by a duly authorized representative of the parties to this Contract. Such amendments shall not invalidate this Contract, nor relieve or release the parties from their obligations under this Contract.
(d) Notwithstanding the preceding, the Project Managers specified in Paragraph 8 and VIHFA may approve extensions to Deliverable Due Dates within the confines of the Performance Period.

## 8. APPROVAL OF KEY PERSONNEL:

VIHFA and the Program Manager reserve the right of final approval of all Contractor's key project management personnel prior to assignment to the project. The Contractor shall provide the following key personnel, as identified in its proposal, for the term of this contract:

During the execution of the project, VIHFA and the Program Manager reserve the right to demand removal of Contractor's key personnel for lack of performance or for any inappropriate or offensive behavior, as defined and determined by VIHFA.
Contractor shall not be responsible for the conduct of any personnel or entities providing service or materials not under Contractor's direct oversight.

## 9. SUBSTITUTION OF KEY PERSONNEL:

Contractor's key personnel assigned to this Contract, listed in the response to the RFP, may not be replaced without the written consent of the VIHFA, provided that such consent shall not be unreasonably withheld or delayed provided an adequately qualified replacement is offered. Notwithstanding the preceding sentence, in the event that any key personnel must

be removed for cause, in Contractor's sole discretion, or becomes unavailable due to resignation, illness, or other factors outside of Contractor's control, Contractor shall be responsible for providing an adequately qualified replacement. Contractor shall provide the resume and qualifications of any proposed substitution for key personnel.

The Contractor shall present to VIHFA and/or the Program Manager all subcontractors and/or subconsultants intended to be by Contractor on this project. Additionally, the Contractor shall provide its written agreement with subcontractors identified in its proposal. Any financial terms and personally identifying information (i.e. social security number) may be redacted from the production to VIHFA. Contractor will not be allowed to join subcontractors and/or sub-consultants to the project without the expressed written approval by VIHFA and/or the Program Manager.
a. Contractor agrees to be responsible for all work performed and all expenses incurred with the project. If VIHFA permits Contractor to subcontract all or part of the work contemplated under this Contract, including entering into subcontracts with vendors for services and commodities, it is understood by Contractor that all such subcontract arrangements shall be evidenced by a written document subject to prior review and comment by VIHFA. Such review of the written subcontract document by VIHFA will be limited to a determination of whether or not subcontracting is permissible and the inclusion of applicable terms and conditions of this Contract. Contractor further agrees that VIHFA shall not be liable to the subcontractor for any expenses or liabilities incurred under the subcontract and Contractor shall be solely liable to the subcontractor for all expenses and liabilities incurred under the subcontract. Contractor, at its expense, will defend VIHFA against such claims.
b. Contractor agrees that all Contractor employees, subcontractors, or agents performing work under the Contract shall be properly trained who meet or exceed any specified training qualifications. Upon request, Contractor shall furnish a copy of technical certification or other proof of qualification. All employees, subcontractors, or agents performing work under the Contract must comply with all security and administrative requirements of VIHFA and shall have all current licenses and permits required for all of the particular work for which they were hired by the Contractor. VIHFA may conduct, and Contractor shall cooperate in, a security background check or otherwise assess any employee, subcontractor, or agent furnished by Contractor. VIHFA may refuse access to, or require replacement of, any personnel for cause, including, but not limited to, technical or training qualifications, quality of work, change in security status, or noncompliance with VIHFA's security or other requirements. Such refusal shall not relieve Contractor of its obligation to perform all work in compliance with the Contract.

## 10. CONTRACTOR'S MANAGEMENT OF CONSTRUCTION SUBCONTRACTORS


(a) Contractor shall not be responsible for the acts of any construction subcontractors, or any of their work performed or expenses incurred or any damages caused in the reconstruction and/or rehabilitation of any property.
10. PROFESSIONAL STANDARDS: The Contractor will complete all work in accordance with standard practices in the construction services management services industry and the work shall conform with any and all laws and regulations which apply to the work being performed, whether or not explicitly covered in the Contract. Contractor warrants that the final product of Contractor's work shall be fit for the purposes for which it is intended.
11. ASSIGNMENT: The Contractor shall not sub-contract or assign any part of the services under this contract without the prior written approval of VIHFA.
12. NON-DISCRIMINATION: The Contractor shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. Such actions shall include but shall not be limited to the following: employment upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.
13. RETENTION OF RECORDS: All records shall be retained for a minimum of three (3) years from the termination or expiration of this Contract, unless notified in writing to extend the retention period. Records shall be made available, without charge, for review within ten (10) days of a request by the VIHFA.
14. NON-DISCLOSURE: Except for disclosure to VIHFA or its representatives, the reports, work papers and records, including information and data prepared or assembled by the Contractor under this Contract, shall be held confidential by the Contractor and shall not be made available or otherwise disclosed to any third party without the prior written approval of VIHFA unless required to disclose information by order of a court of competent jurisdiction or other administrative authority.

## 15. TERMINATION:

## A. Termination/Suspension for Cause

Notwithstanding any other provision of this Contract, VIHFA may, after giving reasonable written notice specifying the effective date, may suspend or terminate this Contract in whole or in part if Contractor materially fails to comply with any material term of this contract, which shall include, but not be limited, to the following:
a. The violation of any of the material terms or conditions of this Contract.
b. The making of any material misrepresentation by the Contractor in the furnishing of any information to the VIHFA.
c. Repeated failure to comply with any of the rules, regulations or provisions referred to herein, or such statutes, regulations, executive orders, and guidelines, policies or directives as may be applicable at any time;
d. Failure, due to Contractor's negligence or willful misconduct, of Contractor to fulfill in a timely and proper manner the obligations under this Contract;
e. Continual submission by Contractor of reports to VIHFA or HUD, or their auditors, reports that are incorrect or incomplete in any material respect, provided Contractor is given notice of said failure and fails to correct the same within a reasonable amount of time; or
f. Improper use of funds as provided for under this Contract. If, through any cause, Contractor shall otherwise fail to fulfill its obligations under this Contract in a timely and proper manner, or if Contractor shall violate any of the covenants or stipulations of this Contract, VIHFA shall thereupon have the right to terminate this Contract by giving written notice to Contractor of such termination and specifying the effective date thereof, at least thirty (30) days prior to the effective date of said termination. Contractor shall be paid for all authorized services properly performed prior to termination.

## B. Termination for Convenience

The continuation of this Contract is contingent upon the appropriation and release of disaster recovery funds to fulfill the requirements of this Contract. Failure of the appropriate authorities to approve and provide an adequate budget to the VIHFA for fulfillment of the Contract terms shall constitute reason for termination for convenience of the Contract by either Party.

## C. Termination Due to Unavailable Funding

The continuation of this Contract is contingent upon the appropriation and release of disaster recovery funds to fulfill the requirements of this Contract. Failure of the appropriate authorities to approve and provide an adequate budget to the VIHFA for fulfillment of the Contract terms shall constitute reason for termination for convenience of the Contract by either Party. VIHFA reserves the right to terminate the contract if funding becomes unavailable and Contractor shall be paid for all authorized Services properly performed prior to Termination plus reasonable termination and demobilization costs incurred.
16. PROCEDURE FOR TERMINATION: VIHFA may terminate this Contract at any time by giving at least sixty (60) days prior written notice to the other Party. Contractor shall be entitled to payment for services performed up to the date of termination contained within the notice, to the extent that the services have been satisfactorily performed and are otherwise reimbursable under the terms of this Contract plus reasonable termination and demobilization costs incurred.
17. FORCE MAJEURE: The Contractor shall not be held responsible for delay or default caused by fire, riot, acts of God, or war, if the event is beyond the Contractor's reasonable control and the Contractor gives notice to the VIHFA promptly upon Contractor's being actually aware of the occurrence of the event causing the delay or default or which is reasonably expected to cause a delay or default. The Parties shall use reasonable efforts to eliminate or minimize the effect of such events on their respective duties under the Contract. Contractor may be entitled to an equitable adjustment in schedules and unit prices in the foregoing circumstances.

## Without limiting the foregoing, Contractor shall not be responsible for any damages, penalties, costs arising from:

## I. Contractor's acts taken at direction of VIHFA;

2. The acts of any third parties, construction subcontractors;
3. The architect or any other professional or consultant
4. lack of or availability of labor, materials and supplies, including long lead items.
5. Conflicts between the various trades or overlapping responsibilities among subcontractors; however, Contractor shall notify VIHFA immediately of any conflicts for VIHFA's resolution
6. Increases in Cost of labor, supplies, materials and equipment to be used in the performance outside of Contractor's control.
7. INSURANCE: The Contractor represents and warrants that Contractor carries professional liability insurance in the amount usual and customary for work in the industry subject to normal deductibles and covenants that Contractor will maintain such coverage as provided in RFP 003-2019-DR-STT/STX during the term of this Contract. - Services performed by Architect after permit approvals to be billed at Architect's hourly rates if required for the project, if required and approved by VIHFA-DR. Attendance at any project meetings to be billed hourly if required and approved by VIHFA-DR.
- Site surveys/plot plans are not required.
- The Case Management Firm shall provide stamped copies of deeds required for permit applications to be supplied by others to the Architect for use in permitting assistance. Cost of printing permit drawings, application copies, earth change map packages, CZM map packages, certified plot plans and other similar documents required by DPNR for permitting, and any permit fees shall be a reimbursable expense if paid for by the Architect for the project.
- Scope of work needed for each project and measurements needed by design team to perform its services to be performed by others (site inspectors). Architect shall be allowed to rely on the accuracy and completeness thereof.
- Drawing sheets to be consolidated to reduce number of sheets as much as feasible. Prints prepared for permitting only as required for that process, as a reimbursable expense.
- Finished drawings to others will be distributed electronically (PDFs) via CDs or USB Flash Drive. (To make things easier I recommend that the Program set up a file sharing website, cloud hosting service, or similar to upload files to. It will be faster and simpler to share information, takes up no physical space, and all stakeholders can be granted access to most updated files stored in one place. Drawings can be accessed and printed on demand if desired, and accessed in the field on mobile devices. Site information from inspectors and photographs can also be stored in project folders for access by the design team.

## 1. PROVISIONS REOUIRED BY LAW DEEMED INSERTED

Each and every provision of law and clause required by law to be inserted in this contract shall be deemed to be inserted herein and the contract shall be read and enforced as though it were included herein, and if through mistake or otherwise any such provision is not inserted, or is not correctly inserted, then upon the application of either party the contract shall forthwith be physically amended to make such insertion or correction.

## 2. STATUTORY AND REGULATORY COMPLIANCE

Contractor/Subcontractor shall comply with all laws and regulations applicable to the Community Development Block Grant-Disaster Recovery funds appropriated by the Disaster Relief Appropriations Act, 2017 (Pub. L. 115-56) and the Bipartisan Budget Act of 2018 ("BBA"), (Pub. L. 115-123), including but not limited to the applicable Office of Management and Budget Circulars, which may impact the administration of funds and/or set forth certain cost principles, including the allowability of certain expenses.

## 3. BREACH OF CONTRACT TERMS

VIHFA reserves its right to all administrative, contractual, or legal remedies, including but not Iimited to suspension or termination of this contract, in instances where the Contractor or any of its subcontractors violate or breach any contract term. If the Contractor or any of its subcontractors violate or breach any contract term, they shall be subject to such sanctions and penalties as may be appropriate. The duties and obligations imposed by the contract documents and the rights and remedies available thereunder shall be in addition to and not a limitation of any duties, obligations, rights and remedies otherwise imposed or available by law.

## 4. REPORTING REQUIREMENTS

The Contractor/Subcontractor shall complete and submit all reports, in such form and according to such schedule, as may be required by VIHFA. The Contractor/Subcontractor shall cooperate with all VIHFA efforts to comply with HUD requirements and regulations pertaining to reporting, including but not limited to 24 C.F.R. $\S \S 85.40-41$ (or $84.50-52$, if applicable) and 570.507.

## 5. ACCESS TO RECORDS

The State, the U.S. Department of Housing and Urban Development, the Comptroller General of the United States, or any of their duly authorized representatives, shall have, at any time and from time to time during normal business hours, access to any work product, books, documents, papers, and records of the Subcontractor which are related to this contract, for the purpose of inspection, audits, examinations, and making excerpts, copies and transcriptions.

## 6. MAINTENANCE/RETENTION OF RECORDS

All records connected with this contract will be maintained in a central location and will be maintained for a period of at least three (3) years following the date of final payment and closeout of all pending matters related to this contract.

The Contractor/Subcontractor shall explain the actual or potential conflict in writing in sufficient detail so that the State is able to assess such actual or potential conflict. The Contractor/Subcontractor shall provide VIHFA any additional information necessary for VIHFA to fully assess and address such actual or potential conflict of interest. The Contractor/Subcontractor shall accept any reasonable conflict mitigation strategy employed by VIHFA, including but not limited to the use of an independent subcontractor(s) to perform the portion of work that gives rise to the actual or potential conflict.

## 16. SUBCONTRACTING

When subcontracting, the Contractor/Subcontractor shall solicit for and contract with such Contractor/subcontractors in a manner providing for fair competition. Some of the situations considered to be restrictive of competition include but are not limited to:
(i) Placing unreasonable requirements on firms in order for them to qualify to do business,
(ii) Requiring unnecessary experience and excessive bonding,

Notwithstanding the above, the Contractor/Subcontractor shall not be relieved of liability to VIHFA for damages sustained by VIHFA by virtue of any breach of the contract by the Contractor/Subcontractor, and VIHFA may withhold any payments to the Contractor/Subcontractor for the purpose of set-off until such time as the exact amount of damages due VIHFA from the Subcontractor is determined.

## 23. TERMINATION FOR CONVENIENCE (Applicable to contracts exceeding $\$ 10,000$ )

VIHFA may terminate this contract at any time by giving at least sixty ( 60 ) days' notice in writing to the Contractor/Subcontractor. If the contract is terminated by VIHFA as provided herein, the Contractor/Subcontractor will be paid for the time provided and expenses incurred up to the termination date.

The Contractor/Subcontractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by the rules, regulations and orders of the Secretary of Labor, or pursuant thereto, and will permit access to books, records and accounts by the contracting agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations and orders.
H. In the event of the Contractor's/Subcontractor's non-compliance with the nondiscrimination clause of this contract or with any of such rules, regulations or orders, this contract may be cancelled, terminated or suspended in whole or in part and the Contractor/Subcontractor may be declared ineligible for further government contracts in accordance with procedures authorized in Executive Order 11246 and such other sanctions as may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation or order of the Secretary of Labor, or as otherwise provided by law.
I. Contractor/Subcontractor shall incorporate the provisions of $A$ through $G$ above in every subcontract or purchase order unless exempted by rules, regulations or orders of the Secretary of Labor so that such provisions shall be binding on such contractor/subcontractor. The Contractor/Subcontractor will take such action with respect to any subcontract or purchase order as the contracting agency may direct as a means of enforcing such provisions including sanctions for non-compliance, provided, however, that in the event the contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the contracting agency, the Contractor/Subcontractor may request the United States to enter into such litigation to protect the interests of the United States.

## 26. CERTIFICATION OF NONSEGREGATED FACILITIES (Applicable to construction contracts exceeding $\$ 10,000$ )

The Contractor/Subcontractor certifies that it does not maintain or provide for its establishments, and that it does not permit employees to perform their services at any location, under its control, where segregated facilities are maintained. It certifies further that it will not maintain or provide for employees any segregated facilities at any of its

establishments, and it will not permit employees to perform their services at any location under its control where segregated facilities are maintained. The Contractor/Subcontractor agrees that a breach of this certification is a violation of the equal opportunity clause of this contract.

As used in this certification, the term "segregated facilities" means any waiting rooms, work areas, rest rooms and wash rooms, restaurants and other eating areas, time clocks, locker rooms, and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation and housing facilities provided for employees which are segregated by explicit directive or are, in fact, segregated on the basis of race, color, religion, or national origin because of habit, local custom, or any other reason.

The Contractor further agrees that (except where it has obtained for specific time periods) it will obtain identical certification from proposed subcontractors prior to the award of subcontracts exceeding $\$ 10,000$ which are not exempt from the provisions of the equal opportunity clause; that it will retain such certifications in its files; and that it will forward the preceding notice to such proposed subcontractors (except where proposed subcontractors have submitted identical certifications for specific time periods).

## 27. CERTIFICATION OF COMPLIANCE WITH CLEAN AIR AND WATER ACTS (Applicable to contracts exceeding $\$ 100,000$ )

The Contractor and all its subcontractors shall comply with the requirements of the Clean Air Act, as amended, 42 U.S.C. $\$ 1857$ et seq., the Federal Water Pollution Control Act, as amended, 33 U.S.C. $\$ 1251$ et seq, and the regulations of the Environmental Protection Agency with respect thereto, at 40 C.F.R. Part 15 and 32, as amended, Section 508 of the Clean Water Act (33 U.S.C. § 1368) and Executive Order 11738.

In addition to the foregoing requirements, all nonexempt contractors and subcontractors shall furnish to the owner, the following:
A. A stipulation by the Contractor or subcontractors, that any facility to be utilized in the performance of any nonexempt contract or subcontract, is not listed on the Excluded Party Listing System pursuant to 40 C.F.R. 32 or on the List of Violating Facilities issued by the Environmental Protection Agency (EPA) pursuant to 40 C.F.R. Part 15, as amended.
B. Agreement by the Subcontractor to comply with all the requirements of Section 114 of the Clean Air Act, as amended, (42 U.S.C. $\S 1857 \mathrm{c}-8$ ) and Section 308 of the Federal Water Pollution Control Act, as amended, (33 U.S.C. § 1318) relating to inspection, monitoring, entry, reports and information, as well as all other requirements specified in said Section 114 and Section 308, and all regulations and guidelines issued thereunder.
C. A stipulation that as a condition for the award of the contract, prompt notice will be given of any notification received from the Director, Office of Federal Activities,

EPA, indicating that a facility utilized, or to be utilized for the contract, is under consideration to be listed on the Excluded Party Listing System or the EPA List of Violating Facilities.
D. Agreement by the Contractor that he will include, or cause to be included, the criteria and requirements in paragraph (A)through (D) of this section in every nonexempt subcontract and requiring that the Contractor will take such action as the government may direct as a means of enforcing such provisions.

## 28. LOBBYING (Applicable to contracts exceeding $\$ 100,000$ )

The Contractor/Subcontractor certifies, to the best of his or her knowledge and belief, that:
(1) No Federal appropriated funds have been paid or will be paid, by or on behalf of the Contractor/Subcontractor, to any person for influencing or attempting to influence an officer or employee of an agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.
(2) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the Contractor/Subcontractor shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.
(3) The Contractor shall require that the language of this certification be included in the award documents for all subawards at all tiers (including subcontracts, subgrants, and contracts under grants, loans, and cooperative agreements) and that all subrecipients shall certify and disclose accordingly.

This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Any person who fails to file the required certification shall be subject to a civil penalty of not less than $\$ 10,000$ and not more than $\$ 100,000$ for each such failure.

## 29. BONDING REQUIREMENTS

(Applicable to construction and facility improvement contracts exceeding $\$ 100,000$ )
The Contractor/Subcontractor shall comply with VIHFA bonding requirements, unless they have not been approved by HUD, in which case the Contractor/Subcontractor shall comply with the following minimum bonding requirements:
(1) A bid guarantee from each bidder equivalent to five percent of the bid price. ## 30. SECTION 3 OF THE HOUSING AND URBAN DEVELOPMENT ACT OF 1968 (As required by applicable thresholds)

A. The work to be performed under this contract is subject to the requirements of section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. § 1701 u (section 3). The purpose of section 3 is to ensure that employment and other economic opportunities generated by HUD assistance or HUD-assisted projects covered by section 3, shall, to the greatest extent feasible, be directed to low- and very low-income persons, particularly persons who are recipients of HUD assistance for housing.
B. The parties to this contract agree to comply with HUD's regulations in 24 C.F.R. part 135, which implement section 3. As evidenced by their execution of this contract. the parties to this contract certify that they are under no contractual or other impediment that would prevent them from complying with the part 135 regulations.
C. The Contractor/Subcontractor agrees to send to each labor organization or representative of workers with which the Contractor/Subcontractor has a collective bargaining agreement or other understanding, if any, a notice advising the labor organization or workers' representative of the Contractor's commitments under this section 3 clause, and will post copies of the notice in conspicuous places at the work site where both employees and applicants for training and employment positions can see the notice. The notice shall describe the section 3 preference, shall set forth minimum number and job titles subject to hire, availability of apprenticeship and training positions, the qualifications for each; and the name and location of the person(s) taking applications for each of the positions; and the anticipated date the work shall begin.
D. The Contractor agrees to include this section 3 clause in every subcontract subject to compliance with regulations in 24 C.F.R. part 135, and agrees to take appropriate action, as provided in an applicable provision of the subcontract or in this section 3 clause, upon a finding that the subcontractor is in violation of the regulations in 24 C.F.R. part 135. The Contractor will not subcontract with any subcontractor where the subcontractor has notice or knowledge that the subcontractor has been

E. The Contractor/Subcontractor will certify that any vacant employment positions, including training positions, that are filled: (1) after the contractor/subcontractor is selected but before the contract is executed, and (2) with persons other than those to whom the regulations of 24 C.F.R. part 135 require employment opportunities to be directed, were not filled to circumvent the Contractor/Subcontractor's obligations under 24 C.F.R. part 135.

Parties to this contract that are subject to the provisions of section 3 and section 7(b) agree to comply with section 3 to the maximum extent feasible, but not in derogation of compliance with section 7(b).

## 31. FAIR HOUSING ACT

Contractor/Subcontractor shall comply with the provisions of the Fair Housing Act of 1968 as amended. The act prohibits discrimination in the sale or rental of housing, the financing of housing or the provision of brokerage services against any person on the basis of race, color, religion, sex, national origin, handicap or familial status. The Equal Opportunity in Housing Act prohibits discrimination against individuals on the basis of race, color, religion, sex or national origin in the sale, rental, leasing or other disposition of residential property, or in the use or occupancy of housing assisted with Federal funds. ## 32. Federal Funding Accountability and Transparency Act (FFATA)

The Federal Funding Accountability and Transparency Act of 2006 (FFATA), as amended, was signed with the intent of reducing wasteful government spending and providing citizens with the ability to hold the government accountable for spending decisions. 2 C.F.R. Part 170 outlines the requirements of recipients' in reporting information on subawards and executive total compensation under FFATA legislation. Any non-Federal entity that receives or administers Federal financial assistance in the form of: grants, loans, loan guarantees, subsidies, insurance, food commodities, direct appropriations, assessed and voluntary contributions; and/or other financial assistance transactions that authorize the non-Federal entities' expenditure of Federal fund, is

33. Procurement

The Uniform Guidance procurement requirements (2 C.F.R. Part 200, Subpart D) went into effect on July 1, 2018. These requirements are applicable to CDBG-DR funded projects, or as provided by 83 Federal Register 5844 VI A(1)(b)(2) permits a state grantee to elect to follow its own procurement policy. These policies and procedures ensure that Federal dollars are spent fairly and encourage open competition at the best level of service and price.

## 34. Change Orders to Contracts

Change orders are issued when the initial agreed upon pricing or work to be completed requires modification. First, the contractor must complete a Change Order Request Form. This form and supporting documentation must be delivered to the Project Manager for review. Each change order must have a cost analysis. Once the Project Manager approves the change order, it is returned to the contractor for execution. Change orders are only invoiced on the final draw and categorized as "change order." The amount listed on the invoice must match the previously approved amount and must be cost reasonable. The Project Manager is responsible for verifying cost reasonableness. Verification documentation for cost reasonableness becomes an attachment to the change order.

## 35. Environmental Review

Every project undertaken with Federal funds, and all activities related to that project, is subject to the provisions of the National Environmental Policy Act of 1969 (NEPA), as well as to the HUD environmental review regulations at 24 C.F.R. Part 58ENVIRONMENTAL REVIEW PROCEDURES FOR ENTITIES ASSUMING HUD ENVIRONMENTAL RESPONSIBILITIES. The primary purpose of this Act is to protect and enhance the quality of our natural environment. The HUD environmental review process must be completed before any Federal funds can be accessed for programeligible activities.

The primary objectives of the HUD environmental review are to identify specific environmental factors that may be encountered at potential project sites, and to develop procedures to ensure compliance with regulations pertaining to these factors. The HUD environmental review is designed to produce program-specific environmental review procedures in a program that can vary greatly in terms of scope of work.

## 37. Environmental Review Record

The Environmental Officer is responsible for maintaining a written record of the environmental review process. The ERR for all programs contains all the governmental review documents, public notices and written determinations or environmental findings required by 24 C.F.R. Part 58- ENVIRONMENTAL REVIEW PROCEDURES FOR ENTITIES ASSUMING HUD ENVIRONMENTAL RESPONSIBILITIES as evidence of review, decision making and actions pertaining to a project of a recipient.

## 38. Flood Insurance Requirements

Grantees and subrecipients of Federal funding must ensure that procedures and mechanisms are put into place to monitor compliance with all flood insurance requirements as found in the Flood Disaster Protection Act of 1973, 24 C.F.R. § $570.605-$ NATIONAL FLOOD INSURANCE PROGRAM and 24 C.F.R. § 570.202- ELIGIBLE REHABILITATION AND PRESERVATION ACTIVITIES.

## 39. Duplication of Benefits

CDBG-DR funding intends to address the unmet needs of a community. The funds are supplemental to primary forms of assistance, including private insurance and FEMA funds. To avoid duplicative assistance and potential de-obligation of funding, agency must utilize all possible funding sources before applying CDBG-DR dollars to a project. CDBG-DR programs are typically implemented after temporary disaster assistance programs, such as FEMA Individual Assistance which are not intended to make someone whole.

The Stafford Disaster Relief and Emergency Assistance Act (Stafford Act), as amended, 42 U.S.C. $\$ 5121$ et seq., established the requirements for Duplication of Benefits (DOB) analysis.

## 40. Anti-Fraud, Waste and Abuse Checks

The Anti-Fraud, Waste and Abuse (AFWA) check is designed to identify discrepancies and risk-relevant issues in Applicant-provided information that may be indicative of fraud, waste, and/or abuse.

## 41. Affirmatively Furthering Fair Housing

The Fair Housing Act of 1968, as amended, 42 U.S.C. $\S 3601$, et seq., dictates that grantees are required to administer all programs and activities related to housing and urban development in a manner to affirmatively further the policies of the Fair Housing Act. Per the regulations of 24 C.F.R. $\S 570.601$ and in accordance with Section 104(b)(2) of the

Housing and Community Development Act of 1974, as amended, 42 U.S.C. § 5301 et seq., for each community receiving a grant under Subpart D of this part, the certification that the grantee will affirmatively further fair housing shall specifically require the grantee to take meaningful actions to further the goals identified in the grantee's Assessment of Fair Housing (AFH) plan, conducted in accordance with the requirements of 24 C.F.R. § §§ $5.150-5.180$ (Affirmatively Furthering Fair Housing) and take no action that is materially inconsistent with its obligation to affirmatively further fair housing.

## 42. Drug Free Workplace

The Drug-Free Workplace Act of 1988, as amended, 41 U.S.C. $\S 81$, as implemented by 24 C.F.R. § Part 24, Subpart F, §§ 983.251-983.262, requires that any grantee other than an individual must certify that it will provide a drug-free workplace. Any grantee found in violation of the requirements of this act may be subject to suspension of payments under the grant, suspension or termination of the grant or suspension or debarment of the grantee.
43. Timely Distribution of Funds

The Supplemental Appropriations for Disaster Relief Requirements, 2017 (Pub. L. 11556), approved September 8, 2017 (Appropriations Act), as amended, requires that funds provided under the Act be expended within two (2) years of the date that HUD obligates funds to a grantee unless otherwise authorized via waiver of this requirement by the Office of Management and Budget (OMB). The OMB waived the two (2) year expenditure requirement under 83 Fed. Reg. 40314 (Aug. 14, 2018); however, the provision to expend one hundred percent ( $100 \%$ ) of the total allocation of CDBG-DR funds on eligible activities within six (6) years of HUD's initial obligation of funds remains in effect. The six (6) year expenditure period commences with the initial obligation of funds provided under 83 Fed. Reg. 5844 (Feb. 14, 2018). Additionally, per 83 Fed. Reg. 5844, the provisions at 24 C.F.R. $\S \S 570.494$ and 570.902 , regarding timely distribution and expenditure of funds, are waived and an alternative requirement was established.

Furthermore, consistent with 31 U.S.C § 1555 and OMB Circular No. A-11 (2017), if the Secretary of HUD or the President of the United States determines that the purposes for which the appropriation was made have been carried out and no disbursement has been made against the appropriation for two (2) consecutive fiscal years, any remaining unobligated balance shall be canceled and will be made unavailable for obligation or expenditure for any purpose.

## 44. Property Management and Distribution

Regulations governing property management and distribution of real property, equipment, financial obligations and return of un-obligated cash post program closeout can be found in 24 C.F.R. § $570.506,2$ C.F.R. § 200.310, 2 C.F.R. § 200.343 and 2 C.F.R. § 200.344(b). The standards of 24 C.F.R. § 570.506 apply to any real property under a CDBG award recipient's control acquired in whole or in part with CDBG funds in excess of $\$ 25,000.00$. The recipient may not change the use or planned use of the property without proper notification to affected citizens and allowable time for comment by them. If the property
is not a building for general government conduct, the use of the property may be changed with citizen approval if it either meets one of the national objectives as defined in 24 C.F.R. § 570.208 or if not, the recipient may either retain or dispose of the property for the changed use if the recipient's CDBG program is reimbursed in the amount of the current fair market value of the property, less any portion of the value attributable to expenditures of nonCDBG funds for acquisition of, and improvements to, the property. Following such reimbursement, the property will no longer be subject to any CDBG requirements.

## 45. Limited English Proficiency

Executive Order No. 13166, signed on August 11, 2000, requires programs, subrecipients, contractors, subcontractors, and/or developers funded in whole or in part with CDBG-DR financial assistance to ensure fair and meaningful access to programs and services for families and individuals with Limited English Proficiency (LEP) and/or deaf/hard of hearing. Fair access is ensured through the implementation of a Language Assistance Plan (LAP), which includes non-English-based outreach, translation services of vital documents, free language assistance services, and staff training. Vital documents are defined as depending on the importance of the program, information, encounter, or service involved, and the consequence to the LEP person if the information in question is not provided accurately or in a timely manner.

## 46. Personally Identifiable Information

In accordance with 2 C.F.R. § 200.303, regarding internal controls of a non-Federal entity, a grantee must guarantee the protection of all Personally Identifiable Information (PII) obtained. The program will enact necessary measures to ensure PII of all applicants is safeguarded as to avoid release of private information. If a contractor or employee should experience any loss or potential loss of PII, the program shall be notified immediately of the breach or potential breach.

## 47. Uniform Relocation Act

CDBG-DR funds are subject to the Uniform Relocation Assistance and Real Property Acquisition Act of 1970 (URA or Uniform Act), as amended. 49 C.F.R. § Part 24 requires relocation assistance for lower-income individuals displaced as a result of the demolition or conversion of a lower-income dwelling and requires one-for-one replacement of lowerincome units demolished or converted to other uses.
48. Residential anti-displacement and relocation assistance plan. Per Section 104(d) of the Housing and Community Development Act of 1974 § 42.325
(a) Certification.
(1) As part of its consolidated plan under 24 CFR Part 91, the recipient must certify that it has in effect and is following a residential anti-displacement and relocation assistance plan.
(2) A unit of general local government receiving funds from the State must certify to the State that it has in effect and is following a residential anti-displacement and relocation

assistance plan, and that it will minimize displacement of persons as a result of assisted activities. The State may require the unit of general local government to follow the State's plan or permit it to develop its own plan. A unit of general local government that develops its own plan must adopt the plan and make it public.
(b) Plan contents.
(1) The plan shall indicate the steps that will be taken consistent with other goals and objectives of the program, as provided in Parts 92 and 570 of this title, to minimize the displacement of families and individuals from their homes and neighborhoods as a result of any assisted activities.
(2) The plan shall provide for relocation assistance in accordance with $\S 42.350$.
(3) The plan shall provide one-for-one replacement units to the extent required by § 42.375

## 49. Complaints and Appeals

Citizen comments on VIHFA's published Action Plan, any substantial amendments to the Action Plan, performance reports and/or other issues related to the general administration of CDBG-DR funds are welcomed throughout the duration of the grant. The Citizen Participation Plan is posted as a stand-alone document at www.vihfa.gov Complaints regarding fraud, waste, or abuse of government funds shall be addressed to the HUD Office of Inspector General Fraud Hotline by phone: 1-800-347-3735 or email: hotline@hudoig.gov.

## 50. Monitoring

As per CDBG regulation, 24 C.F.R. § 570.501 (b), grantees of CDBG-DR funds are responsible for carrying out their programs to meet compliance with CDBG Program, statutory and regulatory requirements, including monitoring their project administrators, contractors and subcontractors. As such, throughout the application, planning, design, and implementation phase of the program, VIHFA will conduct internal monitoring of processes, procedures, policy, applications, planning, design, construction, and other applicable phases.
