

**SERVICES CONTRACT**

**BETWEEN**

**VIRGIN ISLANDS HOUSING FINANCE AUTHORITY**

**AND**

**EVERTEC GROUP, LLC**

This **CONTRACT** (hereinafter referred to as the "Agreement") is made this 19<sup>th</sup> day of October, 2020, in the Territory of the United States Virgin Islands, by and between the **VIRGIN ISLANDS HOUSING FINANCE AUTHORITY**, a body corporate and politic constituting a public corporation and autonomous governmental instrumentality of the Government of the Territory of the United States Virgin Islands, whose address is 3202 Demarara Plaza, Suite 200, St. Thomas, U.S. Virgin Islands 00802-6447 (hereinafter referred to as "VIHFA") and **EVERTEC GROUP, LLC** a foreign limited liability company registered to do business in the U.S. Virgin Islands, whose address is Rd. 176 KM. 1.3 Cupey Bajo, Rio Piedras, San Juan Puerto Rico 00926 (hereinafter referred to as the "Contractor"). Contractor and the VIHFA may sometimes hereinafter be collectively referred to as the "Parties" and individually as a "Party."

**WITNESSETH:**

**WHEREAS**, on September 6, 2017 and on September 19, 2017 Hurricane(s) Irma and Maria (2017 disasters) had a devastating impact on the United States Virgin Islands and caused significant destruction to housing, infrastructure, and the economy; and

**WHEREAS**, as a result of the 2017 disasters, the VIHFA has also been designated as the lead agency for administering the Community Development Block Grant Disaster Recovery ("CDBG-DR"), which is authorized under the Additional Supplemental Appropriations for Disaster Relief Requirements Act of No. 2017, Public Law (P.L.) 115-56, and the Further Additional Supplemental Appropriations for Disaster Relief Requirements Act of 2018, P.L. 115-123; and

**WHEREAS**, the U.S. Department of Housing and Urban Development (HUD) awarded \$1,863,742,000.00 of CDBG-DR funds to the U.S. Virgin Islands in two separate tranches. On, February 2, 2018, the first \$242,684,000 was announced for Tranche 1 and on April 10, 2018, an additional \$779,217,000 for Tranche 2; and

**WHEREAS**, under Public Law (P.L.) 115-56, and the Further Additional Supplemental Appropriations for Disaster Relief Requirements Act of 2018, P.L. 115-123, HUD the awarded CDBG-DR funds must be used for the purpose of assisting in addressing unmet needs from the 2017 disasters; and

**WHEREAS**, on December 19, 2019 the VIHFA issued a Request for Proposals, IFB 007-2020-DR-STT/STX to solicit proposals from qualified and licensed firms ("Respondents") to provide cloud based productivity suite services for the VIHFA's CDBG-DR funded programs; and

**WHEREAS**, the VIHFA desires to enter into an agreement with the Contractor to secure the translation of all public notices, Action Plans, and other documents associated with the CDBG-DR program, as determined by VIHFA, and accepts the Contractor's proposal;

**WHEREAS**, the Contractor by its acceptance of the terms and conditions of this Contract is willing and capable to provide the services contemplated under this Contract; and

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained, and intending to be legally bound by this written instrument, the parties hereto do covenant and agree as follows:

**1. SCOPE OF WORK:**

The Contractor shall perform, or cause to be performed, the following services through a subscription service of its Microsoft 365 E5 cloud base suite:

- i. The CBPS is hosted in a highly secure and geographically redundant data center, located within the United States of America. No network and data sharing/replication to any data centers outside the boundaries of the country.
- ii. The respondent provides an email solution which is accessible from anywhere in the world, via multiple devices (Minimum 5 devices per user such as; tablets, smart phones, laptops, desktops etc.) and all the devices should have the capability to sync with one another.
  - a) Meeting/Calendar/Task list should feature;
  - b) Accessible via multiple web browsers available in the marketplace;
  - c) Email archiving and advanced security solutions such as end to end encryption;
  - d) Integration with audio conference bridge and video conference software solutions available in the marketplace; and
  - e) Integration with Concierge Management Software (for automatic setup of audio bridge or video conference meeting room/place along with URL to connect with these meeting services).
- iii. The CBPS should support an enterprise wide files sharing/ collaboration environment.
- iv. The CBPS should support online audio/ video conferencing on all PC/MAC laptops, tablets, and smartphone devices.
- v. The CBPS should have the capability to integrate with VIHFA's existing Active Directory server.
- vi. The CBPS should be compatible with VIHFA's current Desktop operating system environment (Windows 7/10).
- vii. The CBPS should support an online storage/ repository area for all end users to share files (Accessible from all devices after successful authentication).
- viii. The CBPS should support message broadcasting (One to one, one to Many, Many to many).

- ix. The proposed CBPS should be IPv4/ IPv6 Compliant, with dual stack compatibility.
- x. The CBPS objects are a part of widely accepted Industry standard for Email/Word/Spreadsheet/Presentation software solution, so that the VIHFA's documents are interoperable with its customers, business partners and regulators.
- xi. The CBPS should have the capability to create professional diagrams such as flowcharts, diagrams, organizational charts, floor plans and more via Microsoft Visio. We anticipate the need for fifteen (15) such licenses in total, as add on software
- xii. The CBPS should have Mobile Device Management and/or Enterprise Mobility Management capabilities to manage agency mobile devices (laptops, tablets and cellular phones) and personal devices in Bring Your Own Device (BYOD) scenarios.
- xiii. The CBPS should have a unified enterprise-grade anti-threat protection platform capable of preventative protection, post-breach detection and, automated investigation and response.
- xiv. The respondent provides the following options relative to training:
  - a) Online, webinar or CBT based training course.
  - b) Curriculum should include, but not be limited to admin console configuration, operation/functionalities, maintenance, support & administration for software/ /hardware/ Database/ OS/ Middleware, application architecture and components, installation, troubleshooting processes of a proposed cloud-based productivity suite/services.
  - c) VIHFA is also requesting that refresher courses for high level administrators and end users, be available to staff on an annual basis. The refresher course can be conducted via video, webinars and offline documentation.
- xv. As a CSP, Evertec recommends a server with the AD Connect services to synchronize with the VIHFA's Active Directory to have its own Microsoft Office 365 subscription with its own infrastructure. Finally, VIHFA will administrate its own Microsoft Office 365 environment will have their own Hybrid Exchange servers for mailbox migration to the cloud. Also, Evertec will install remotely the Office 365 applications, such as Word, Excel, Power Point, Outlook, Yammer SharePoint, Delve, Skype/Lync, etc.)
- xvi. Evertec will provide the services to move 90 licenses from the Microsoft Office 365 E3 subscription to Microsoft 365 E5 subscription and will configure 40 licenses of Microsoft 365 E5 in standby mode. Additional, Evertec will provide and configure remotely 15 licenses for Visio Online Plan 2. A preliminary scope of the tasks which will take place in order to execute a successful migration follows:

VIHFA acknowledges and agrees (i) it has selected Evertec as its reseller for the Microsoft Cloud Services Provider hereunder, and (ii) with the applicable Microsoft Cloud Agreement (<https://www.microsoft.com/en-us/servicesagreement>) for cloud customers, which may change from time to time by Microsoft.

**2. TERM:**

This Contract shall begin on or about 19th day of October, 2020 or the date on which the last Party has signed the Contract, whichever is later, and shall end on or about 18th day of October 2022. The VIHFA may elect to exercise the option for two (2) additional two (2) year subscription term(s), subject to Contractor's satisfactory performance. VIHFA will exercise this option by providing Contractor written notice no less than sixty (60) days prior to the expiration of the first contract term.

**3. COMPENSATION:**

- (a) VIHFA, in consideration of satisfactory performance of the services described above, shall pay the Contractor as compensation for the services rendered under this contract an amount not to exceed Two Hundred Thirty-Seven Thousand Four Hundred and Ninety-Four Dollars and 25/100 (\$237,494.25). Contractor shall submit invoices for the number of licenses as outlined in Appendix A. Contractor shall submit monthly invoices to VIHFA for payment.
- (b) VIHFA's performance and obligation to pay under this Contract is contingent upon the availability of applicable disaster recovery funds. VIHFA shall be the final authority as to the availability of funds for this Contract and as to what constitutes "applicable funding" to complete this Contract. If any such funds are not made available for the Contract purpose, such event will not constitute a default on VIHFA. VIHFA will notify Contractor in writing at the earliest possible time, but not less than thirty (30) days, if funds are not appropriated or available. The cost for services rendered under this Contract to be paid is not eligible for reimbursement from any other funding source.
- (c) It is expressly understood and agreed that in no event shall the amounts to be paid by the VIHFA to the Contractor under this Contract exceed the rates and conditions made a part of this Contract unless expressly agreed to in writing.

**4. REPRESENTATIONS, WARRANTIES, AND COVENANTS BY CONTRACTOR:**

The Contractor represents, warrants, and covenants as follows:

- (a) Contractor is duly organized and existing under the laws of the Commonwealth of Puerto Rico and authorized, qualified and licensed to do business in the United States Virgin Islands.
- (b) Contractor will, during the term of this Contract, remain engaged in the business of providing cloudbased services and remain in good standing and qualified to do business under the laws of the Territory, including maintenance at all times of a valid V.I. business license.
- (c) .
- (d) Contractor has the power to execute, deliver and perform, and enter into the transactions contemplated by this Agreement, and has duly authorized the execution, delivery, and performance of this Agreement.
- (e) The execution and delivery of this Agreement, the consummation of the transaction contemplated hereby and the fulfillment or compliance with the terms and conditions of this Agreement do not and will not conflict with or result in a breach of any of the terms, conditions, or provisions of any legal restrictions or any agreement or instrument to which the Contractor is now a party or by which Contractor is bound or constitute a default under any of the foregoing.
- (f) No information, statement, or report furnished in writing by the Contractor in connection with the negotiation of, or performance under, this Agreement and the consummation of the transactions contemplated hereby, knowingly contains any material misstatement of fact or omits to state a material fact that would make the information, statement or report misleading.
- (g) That Contractor has obtained all the applicable licenses or permits, temporary or otherwise, as required by Title 27 of the Virgin Islands Code; and familiarized itself with the applicable provisions of Title 27 of the Virgin Islands Code pertaining to professions and occupations.

**5. CONTRACTOR RESPONSIBILITY:**

Contractor shall supervise and direct the work of its employees and subcontractors. Contractor agrees to maintain the standards applicable to its industry.

Contractor shall be responsible for its performance and that of its material subcontractors (“Subcontractors”) and vendors (“Vendors”). The Government hereby consents that Contractor may use Kryonyx Corporation as a Subcontractor.

Unless otherwise specified in this Contract, the Contractor will provide for and/or pay for all labor, materials, equipment, tools, machinery, transportation, and other goods, facilities, and services necessary for the proper execution and completion of the work within its scope.

## 6. VIHFA RESPONSIBILITY:

VIHFA will take primary responsibility of providing access to Evertec's subject matter experts the necessary infrastructure requirements and any other key information related to the proposed solution. If our team is unable to perform services as a result of VIHFA documented inability to deliver appropriate resources, our team will not be held liable for such failure to perform.

It is further assumed that Peter Mitchell, or his designee, is the assigned project manager to manage and serve as liaison with our team during the life of the service contract.

## 7. PAYMENT PROCESS:

- a. Invoices shall be submitted on a monthly basis.
- b. Compensation shall be invoiced as outlined in *Appendix A*. VIHFA will notify Contractor of any disputed charges within fifteen (15) days.
- c. Indemnification: Should the Contractor, after receipt of payment of invoices from the VIHFA fail to pay in a timely manner all persons who have fulfilled their obligations to perform labor and/or furnish materials in the prosecution of the work provided for herein, including by way of example Contractor's employees, subcontractors and furnishers of materials, machinery, equipment and fixtures, then Contractor agrees to indemnify VIHFA for said payment(s). Timely payments from Contractor to its Subcontractors and Vendors shall mean within three (3) business days of receiving payment from VIHFA.

## 8. AMENDMENTS:

The VIHFA may at any time, with written notice to the Contractor, request changes within the scope of services of this Contract. Upon mutual written agreement with Contractor, such changes may include modifications, additions or expansion of the contracted services. Upon mutual written agreement with Contractor, VIHFA may amend this Contract to conform with federal, state, or local governmental guidelines, policies, and available funding amounts.

The Contractor may submit to the VIHFA a request for a change in the scope of work under this Contract. The Contractor will prepare a detailed written description of the change request and a proposed price of making such change. If the Authority does not agree with the need for the change or with its price, the Authority can decline its acceptance with no cost obligation incurred. If the Authority agrees to the change, the Authority will negotiate with the Contractor and agree to a firm fixed price for the change. The Contractor will not be authorized to proceed until a properly executed amendment is in place.

Amendments to this Contract must be in writing and must be signed by a duly authorized representative of the parties to this Contract. Such amendments shall not invalidate this Contract, nor relieve or release the parties from their obligations under this Contract.

Notwithstanding the preceding, the Project Managers specified in Paragraph 6 and VIHFA may approve extensions to Deliverable Due Dates within the confines of the Performance Period.

**9. INDUSTRY STANDARDS:**

The Contractor will complete all work in accordance with standard practices in the industry and the work shall conform with any and all law and regulations which apply to the work being performed, explicitly covered in the Contract.

**10. ASSIGNMENT:**

The Contractor shall not sub-contract or assign any part of the services under this contract without the prior written approval of VIHFA. As mentioned in Section 5, the Government hereby consents that Contractor may use Kryonyx Corporation.

**11. NON-DISCRIMINATION:**

The Contractor shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. Such actions will include but shall not be limited to the following: employment upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.

**12. RETENTION OF RECORDS:**

All reasonable records related to the time and money for the services provided hereunder shall be retained for a minimum of three (3) years from the termination or expiration of this Contract, unless notified in writing to extend the retention period. Records shall be made available, without charge, for review within fifteen (15) days of a written request by the VIHFA.

**13. NON-DISCLOSURE:**

Except for disclosure to the Authority or its representatives, the reports, work papers and records, including information and data prepared or assembled by the Contractor under this Contract, shall be held confidential by the Parties and shall not be made available or otherwise disclosed to any third party without the prior written approval of the other Party unless required to disclose information by order of a court of competent jurisdiction or other administrative authority.

**14. TERMINATION:**

**A. Termination/Suspension for Cause**

Notwithstanding any other provision of this Contract, the Authority may, after giving reasonable sixty (60) day prior written notice specifying the effective date, may suspend or terminate this contract in whole or in part, if Contractor materially fails to comply with

**C. Termination Due to Unavailable Funding**

The continuation of this Contract is contingent upon the appropriation and release of disaster recovery funds to fulfill the requirements of this Contract. Failure of the appropriate authorities to approve and provide an adequate budget to the VIHFA for fulfillment of the Contract terms shall constitute reason for termination for convenience of the Contract by either Party. Contractor shall be paid for all authorized Services properly performed prior to Termination plus reasonable termination and demobilization costs incurred.

**15. PROCEDURE FOR TERMINATION:**

The VIHFA may terminate this Contract, as set forth in Section 13, by notifying the Contractor in writing at least sixty (60) days before the date upon which termination shall be effective. Upon termination and the effective date thereof, the Contractor shall utilize the time that reasonably may be required for the purpose of closing work hereunder. All charges incurred shall be paid by the Authority upon submission of a final invoice by the Contractor.

**16. FORCE MAJEURE:**

The Contractor shall not be held responsible for delay or default caused by fire, riot, acts of God, pandemics, hurricanes or war, if the event is beyond the Contractor's reasonable control and the Contractor gives notice to the VIHFA diligently (but no later than seven (7) days) upon occurrence of the event causing the delay or default or which is reasonably expected to cause a delay or default. The Parties shall use reasonable efforts to eliminate or minimize the effect of such events on their respective duties under the Contract. Contractor may be entitled to an equitable adjustment in schedules and unit prices in the foregoing circumstances.

**17. INSURANCE:**

The Contractor represents and warrants that Contractor carries liability insurance in the amount usual and customary for a businesses of similar size, subject to normal deductibles, and covenants that Contractor will maintain such coverage as provided in IFB 007-2020-DR-STT/STX during the term of this Contract. Contractor shall also secure Liability insurance covering acts, errors or omissions arising out of, or failure to render, services related to the Services under this Agreement. The Contractor's liability insurance policy shall name the VIHFA as an "Additional Insured". Evidence of public liability insurance shall be delivered to VIHFA within Ten (10) working days after the award.

Upon failure of the Contractor to furnish, deliver and maintain such insurance, this contract, at the election of the VIHFA may be suspended, discontinued or terminated. Failure of the Contractor to purchase and/or maintain any required insurance shall not relieve the Contractor from any liability or indemnification under the contract.

Contractor shall include all Subcontractors as insureds under its policies and shall be responsible for verifying and maintaining the certificates provided by each Subcontractor. Subcontractors

shall be subject to all of the requirements contained herein. VIHFA reserves the right to request copies of Subcontractor's certificates at any time.

**18. INDEMNIFICATION:**

The Contractor shall indemnify, defend, and hold harmless VIHFA, its property, consultants, employees, and the funding agency harmless from and against all claims, damages, losses, and expenses, direct damages arising out of or resulting solely from the Contractor's negligent act or omission of the Contractor, its subcontractor(s), any person or organization directly employed by them to perform or furnish any of the Work up to the maximum amount paid by VIHFA under this Agreement.

**19. FALSE CLAIMS:**

The Contractor warrants that it shall not, with respect to this Contract, make or present any knowingly false claim upon or against VIHFA. The Contractor acknowledges that making such a false, fictitious, or fraudulent claim is an offense under federal law (31 U.S. Code Section 3729)..

**20. CONFLICT OF INTEREST:**

The Contractor covenants that it has no interest and will not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance of services required to perform under this Contract.

**21. WARRANTY OF NON-SOLICITATION:**

Except for Contractor's salesforce, the Contractor expressly warrants that it has not employed any person to solicit or obtain this contract on its behalf, or cause or procure the same to be obtained upon compensation in any way, contingent, in whole or in part, upon such procurement, and that it has not paid, or promised or agreed to pay to any person, in consideration of such procurement, or in compensation for services in connection therewith, any brokerage, commission, or percentage upon the amount receivable by it hereunder; and that it has not, in estimating the contract price demand, included any sum by reason of such brokerage, commission or percentage, and that all monies payable to it hereunder are free from obligation to any other person for services rendered, supposed to have been rendered, in the procurement of this contract. Breach of this warranty shall give VIHFA the right to terminate this Contract or, in its discretion, to deduct from the Contract Cost or consideration the amount of such commission, percentage, brokerage or contingent fees.

**22. INDEPENDENT CONTRACTOR:**

The Contractor shall perform this Contract as an independent contractor and nothing herein contained shall be construed to be inconsistent with this relationship or status. The Contractor shall be responsible for the supervision of Contractor's employees, subcontractors, and authorized representatives, if any. All workers must be competent and skilled in their work.

Nothing in this Contract shall be contained to impose any liability upon VIHFA, or to persons, firms, associations, or corporations engaged by the Contractor as servants, agents, independent contractors, or in any other capacity whatsoever, or to make VIHFA liable to any such persons, firms, associations or corporation for the acts, omissions, responsibilities, obligations and taxes of Contractor of whatsoever nature, including but not limited to unemployment insurance and social security taxes for the Contractor, its servants, agents or independent contractors.

Any notices required or permits to be given under this Contract shall be deemed sufficiently given or served if sent by certified mail, return receipt requested to the parties at the following addresses:

### 25. TAXES:

Contractor is responsible for payment of all applicable federal and local Territorial taxes, including any taxes of any out-of-state employees who are currently assigned to this project and are working within the Territory.

- (a) **GROSS RECEIPT TAXES:** Title 33 V.I.C. Ch.3, §44, as amended<sup>1</sup>, requires VIHFA, when making a payment under this Contract, to deduct and withhold from such payments, gross receipts taxes as required by law at 33 VIC Section 43(a) for each payment for Work performed in the Virgin Islands. It is agreed between the Parties that for the purposes of complying with Title 33, Ch. 3, Section 44 of the Virgin Islands Code, VIHFA shall withhold and forward to the Virgin Islands Bureau of Internal Revenue (“VIBIR”) such amount as required by the law at 33 VIC Section 43(a) or any amendments thereto.
- (b) The Contractor agrees that the calculation and payment of gross receipts taxes shall be its sole responsibility. The Authority shall not be responsible in any way for any miscalculation, or additional assessments by the VIBIR resulting from Work performed under this Contract. In the unlikely event any overpayment or underpayment is made to the VIBIR, the Contractor shall resolve such matter with VIBIR and inform the Authority of the resolution thereof.

## 26. VIHFA FURNISHED RESOURCES:

The VIHFA will provide specific project information to Contractor necessary to complete Services described herein. All records, reports, documents and other material delivered or transmitted to Contractor by the VIHFA shall remain the property of the VIHFA and shall be returned by Contractor to the VIHFA, upon request, at termination, expiration or suspension of this Contract. All records, reports, documents, or other material or data, including electronic data, related to this Contract and/or obtained or prepared by Contractor, and all repositories and databases compiled or used, regardless of the source of information included therein, in connection with performance of the Services contracted for herein shall become the property of the VIHFA, and shall, upon request, be returned by Contractor to the VIHFA at termination or expiration of this Contract. Cost incurred by Contractor to compile and transfer information for return to the VIHFA shall be billed on a time basis, subject to the maximum amount of this Contract. Software and other materials owned by Contractor prior to the date of this Contract and not related to this Contract shall be and remain the property of Contractor.

## 27. FUND USE:

Contractor agrees not to use proceeds from this Contract to urge any elector to vote for or against any candidate or proposition on an election ballot nor shall such funds be used to lobby for or against any proposition or matter having the effect of law or is being considered by the Government of the U.S. Virgin Islands.





2. STATUTORY AND REGULATORY COMPLIANCE

withhold any payments to the Contractor/Subcontractor for the purpose of set-off until such time as the exact amount of damages due VIHFA from the Subcontractor is determined.

23. TERMINATION FOR CONVENIENCE (Applicable to contracts exceeding \$10,000)

See Section 14(b) of the Contract.

24. SECTION 503 OF THE REHABILITATION ACT OF 1973 (Applicable to contracts exceeding \$10,000)

The Contractor/Subcontractor shall comply with section 503 of the Rehabilitation Act of 1973 (29 U.S.C. § 793), as amended, and any applicable regulations.

Equal Opportunity for Workers With Disabilities

1. 31. Federal Funding Accountability and Transparency Act (FFATA)

The Federal Funding Accountability and Transparency Act of 2006 (FFATA), as amended, was signed with the intent of reducing wasteful government spending and providing citizens with the ability to hold the government accountable for spending decisions. 2 C.F.R. § Part 170 outlines the requirements of recipients' in reporting information on subawards and executive total compensation under FFATA legislation. The Uniform Guidance procurement requirements (2 C.F.R. § Part 200, Subpart D) went into effect on July 1, 2018. These requirements are applicable to CDBG-DR funded projects, or as provided by 83 Federal Register 5844 VI A(1)(b)(2) permits a territory grantee to elect to follow its own procurement policy. Once the Project Manager approves the change order, it is returned to the contractor for execution. Change orders are only invoiced on the final draw and categorized as "change order." The amount listed on the invoice must match the previously approved amount and must be cost reasonable. The Project Manager is responsible for verifying cost reasonableness. Verification documentation for cost reasonableness becomes an attachment to the change order.

34. Environmental Review

Every project undertaken with Federal funds, and all activities related to that project, is subject to the provisions of the National Environmental Policy Act of 1969 (NEPA), as well as to the HUD environmental review regulations at 24 C.F.R. § Part 58- ENVIRONMENTAL REVIEW PROCEDURES FOR ENTITIES ASSUMING HUD ENVIRONMENTAL RESPONSIBILITIES. The primary purpose of this Act is to protect and enhance the quality of our natural environment. The HUD environmental review process must be completed before any Federal funds can be accessed for program-eligible activities.

The primary objectives of the HUD environmental review are to identify specific environmental factors that may be encountered at potential project sites, and to develop procedures to ensure compliance with regulations pertaining to these factors. The HUD environmental review is designed to produce program-specific environmental review procedures in a program that can vary greatly in terms of scope of work.

37. Flood Insurance Requirements

Grantees and subrecipients of Federal funding must ensure that procedures and mechanisms are put into place to monitor compliance with all flood insurance requirements as found in the Flood Disaster Protection Act of 1973, 24 C.F.R. § 570.605- NATIONAL FLOOD INSURANCE PROGRAM and 24 C.F.R. § 570.202- ELIGIBLE REHABILITATION AND PRESERVATION ACTIVITIES.

38. Duplication of Benefits

CDBG-DR funding intends to address the unmet needs of a community. The funds are supplemental to primary forms of assistance, including private insurance and FEMA funds. To avoid duplicative assistance and potential de-obligation of funding, subrecipient must utilize all possible funding sources before applying CDBG-DR dollars to a project. CDBG-DR programs are typically implemented after temporary disaster assistance programs, such as FEMA Individual Assistance which are not intended to make someone whole.

The Stafford Disaster Relief and Emergency Assistance Act (Stafford Act), as amended, 42 U.S.C. §5121 et seq., established the requirements for Duplication of Benefits (DOB) analysis.

39. Anti-Fraud, Waste and Abuse Checks

The Anti-Fraud, Waste and Abuse (AFWA) check is designed to identify discrepancies and risk-relevant issues in Applicant-provided information that may be indicative of fraud, waste, and/or abuse.

40. Affirmatively Furthering Fair Housing

The Fair Housing Act of 1968, as amended, 42 U.S.C. §3601, et seq., dictates that grantees are required to administer all programs and activities related to housing and urban development in a manner to affirmatively further the policies of the Fair Housing Act. 41. Drug Free Workplace

42. Timely Distribution of Funds

The Supplemental Appropriations for Disaster Relief Requirements, 2017 (Pub. L. 115-56), approved September 8, 2017 (Appropriations Act), as amended, requires that funds provided under the Act be expended within two (2) years of the date that HUD obligates funds to a grantee unless otherwise authorized via waiver of this requirement by the Office of Management and Budget (OMB). The OMB waived the two (2) year expenditure requirement under 83 FR 40314; however, the provision to expend one hundred percent (100%) of the total allocation of CDBG-DR funds on eligible activities within six (6) years of HUD's initial obligation of funds remains in effect. The six (6) year expenditure period commences September 27, 2018 with the initial obligation of funds provided under 83 FR 5844. Additionally, per 83 FR 5844, the provisions at 24 C.F.R. § 570.494 and 24 C.F.R. § 570.902, regarding timely distribution and expenditure of funds, are waived and an alternative requirement was established.

Furthermore, consistent with 31 U.S.C §1555 and OMB Circular No. A-11 (2017), if the Secretary of HUD or the President of the United States determines that the purposes for which the appropriation was made have been carried out and no disbursement has been made against the appropriation for two (2) consecutive fiscal years, any remaining unobligated balance shall be canceled and will be made unavailable for obligation or expenditure for any purpose.

43. Property Management and Distribution (the Parties agree this is not a Property Management and Distribution Agreement)

Regulations governing property management and distribution of real property, equipment, financial obligations and return of un-obligated cash post program closeout can be found in 24 C.F.R. § 570.506, 2 C.F.R. § 200.310, 2 C.F.R. § 200.343 and 2 C.F.R. § 200.344(b). The standards of 24 C.F.R. § 570.506 apply to any real property under a CDBG award recipient's control acquired or improved in whole or in part with CDBG-DR funds in excess of the simplified acquisition threshold, which is \$250,000.00. The recipient may not change the use or planned use of the property without proper notification to affected citizens and allowable time for comment by them. If the property is not a building for general government conduct, the use of the property may be changed with citizen approval if it either meets one of the national objectives as defined in 24 C.F.R. § 570.208 or if not, the recipient may either retain or dispose of the property for the changed use if the recipient's CDBG-DR program is reimbursed in the amount of the current fair market value of the property, less any portion of the value attributable to expenditures of non-CDBG-DR funds for acquisition of, and improvements to, the property. Following such reimbursement, the property will no longer be subject to any CDBG requirements.

44. Limited English Proficiency (It is the understanding of the Parties that this section is not applicable to this Contract)

Executive Order No. 13166, signed on August 11, 2000, requires programs, subrecipients, contractors, subcontractors, and/or developers funded in whole or in part with CDBG-DR financial assistance to ensure

fair and meaningful access to programs and services for families and individuals with Limited English Proficiency (LEP) and/or deaf/hard of hearing. Fair access is ensured through the implementation of a Language Assistance Plan (LAP), which includes non-English-based outreach, translation services of vital documents, free language assistance services, and staff training. Vital documents are defined as depending on the importance of the program, information, encounter, or service involved, and the consequence to the LEP person if the information in question is not provided accurately or in a timely manner.

45. Personally Identifiable Information

In accordance with 2 C.F.R. § 200.303, regarding internal controls of a non-Federal entity, a grantee must guarantee the protection of all Personally Identifiable Information (PII) obtained. The program will enact necessary measures to ensure PII of all applicants is safeguarded as to avoid release of private information. If a contractor or employee should experience any loss or potential loss of PII, the program shall be notified immediately of the breach or potential breach as provided in section 28 of the Contract.

46. Uniform Relocation Act (the Parties agree this is not a relocation assistance contract)

CDBG-DR funds are subject to the Uniform Relocation Assistance and Real Property Acquisition Act of 1970 (URA or Uniform Act), as amended. 49 C.F.R. § Part 24 requires relocation assistance for lower-income individuals displaced as a result of the demolition or conversion of a lower-income dwelling and requires one-for-one replacement of lower-income units demolished or converted to other uses.

47. Residential anti-displacement and relocation assistance plan. Per Section 104(d) of the Housing and Community Development Act of 1974 § 42.325 (the Parties agree this is not an anti-displacement and relocation assistance plan contract)

(a) Certification.

(1) As part of its consolidated plan under 24 CFR part 91, the recipient must certify that it has in effect and is following a residential anti-displacement and relocation assistance plan.

(2) A unit of general local government receiving funds from the Territory must certify to the Territory that it has in effect and is following a residential anti-displacement and relocation assistance plan, and that it will minimize displacement of persons as a result of assisted activities. The Territory may require the unit of general local government to follow the Territory's plan or permit it to develop its own plan. (3) The plan shall provide one-for-one replacement units to the extent required by § 42.375.

49. Monitoring

As per CDBG regulation, 24 C.F.R. § 570.501(b), grantees of CDBG-DR funds are responsible for carrying out their programs to meet compliance with CDBG Program, statutory and regulatory requirements, including monitoring their project administrators, contractors and subcontractors. As such, throughout the application, planning, design, and implementation phase of the program, VIHFA will conduct internal monitoring of processes, procedures, policy, applications, planning, design, construction, and other applicable phases.

50. Procurement of Recovered Materials

A non-Federal entity that is a state agency or agency of a political subdivision of a state and its contractors must comply with section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act. The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 CFR part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition, where the purchase price of the item exceeds \$10,000 or the value of the quantity acquired during the preceding fiscal year exceeded \$10,000; procuring solid waste management services in a manner that maximizes energy and resource recovery; and establishing an affirmative procurement program for procurement of recovered materials identified in the EPA guidelines.
