

**PROFESSIONAL SERVICES CONTRACT**

**Between**

**VIRGIN ISLANDS HOUSING FINANCE AUTHORITY**

**&**

**ISLAND SERVICES GROUP LLC**

This **CONTRACT** (hereinafter referred to as the "Agreement") is made this day of <sup>January 27,</sup> \_\_\_\_, 2021, in the Territory of the United States Virgin Islands, by and between the **VIRGIN ISLANDS HOUSING FINANCE AUTHORITY**, a body corporate and politic constituting a public corporation and autonomous governmental instrumentality of the Government of the Territory of the United States Virgin Islands, whose address is 3202 Demarara Plaza, Suite 200, St. Thomas, U.S. Virgin Islands 00802-6447 (hereinafter referred to as "**VIHFA**") and **ISLAND SERVICES GROUP, LLC** a domestic limited liability company, whose address is 109-113 Castle Coakley, Christiansted, St. Croix U.S. Virgin Islands 00820 (hereinafter referred to as the "**Contractor**"). Contractor and the VIHFA may sometimes hereinafter be collectively referred to as the "Parties" and individually as a "Party."

**WITNESSETH:**

**WHEREAS**, on September 6, 2017 and on September 19, 2017 Hurricane(s) Irma and Maria (2017 disasters) had a devastating impact on the United States Virgin Islands and caused significant destruction to housing, infrastructure, and the economy; and

**WHEREAS**, as a result of the 2017 disasters, the VIHFA has also been designated as the lead agency for administering the Community Development Block Grant Disaster Recovery ("CDBG-DR"), which is authorized under the Additional Supplemental Appropriations for Disaster Relief Requirements Act of No. 2017, Public Law (P.L.) 115-56, and the Further Additional Supplemental Appropriations for Disaster Relief Requirements Act of 2018, P.L. 115-123; and

**WHEREAS**, the U.S. Department of Housing and Urban Development (HUD) awarded \$1,863,742,000.00 of CDBG-DR funds to the U.S. Virgin Islands in two separate tranches. On, February 2, 2018, the first \$242,684,000 was announced for Tranche 1 and on April 10, 2018, an additional \$779,217,000 for Tranche 2; and

**WHEREAS**, under Public Law (P.L.) 115-56, and the Further Additional Supplemental Appropriations for Disaster Relief Requirements Act of 2018, P.L. 115-123, HUD the awarded CDBG-DR funds must be used for the purpose of assisting in addressing unmet needs from the 2017 disasters; and

**WHEREAS**, on May 12, 2020 the VIHFA issued a Request for Proposals, RFP 005-2020-VIHFA-CDBG-DR-STT/STX to solicit proposals from qualified and licensed firms ("Respondents") to provide warehouse management services for the VIHFA's CDBG-DR funded programs; and

**WHEREAS**, the VIHFA desires to enter into an agreement with the Contractor to provide warehouse management services, as determined by VIHFA, and accepts the Contractor's proposal;

**WHEREAS**, the Contractor by its acceptance of the terms and conditions of this Contract is willing and capable to provide the services contemplated under this Contract; and

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained, and intending to be legally bound by this written instrument, the parties hereto do covenant and agree as follows:

**1. SCOPE OF WORK:**

The Contractor shall perform, or cause to be performed, the following services:

- a) Adherence to federal program guidelines.
- b) Regularly assess the conditions of the location and the control systems.
- c) Provide regular cleaning and maintenance of each site.
- d) Develop and implement the building operations and preventative maintenance programs necessary to maintain, preserve, and keep the premises in good repair and condition.
- e) Interact with construction managers and contractors on a daily basis.
- f) Respond promptly to inquiries, schedule site visits and inspections, within program guidelines.
- g) Detect and prevent fraud, waste, and abuse.
- h) Store, handle and dispatch of materials
- i) Track materials as needed.
- j) Ensure continual quality assurance/quality control.
- k) Provide daily and periodic communication/reports, to include status of inventory, deliveries, and release to VIHFA program staff.
- l) Maintain documentation of materials to allow an audit trail of all materials on-hand, used, purchased, etc. through closeout.
- m) Ability to provide services in multiple languages as necessary, including English and Spanish.

Start-up of Operations

- n) Secure the necessary personnel, computers, vehicles, supervision, telecommunications equipment, and all other equipment/supplies as necessary to conduct business for the core functions of warehouse management at sites on St. Thomas and St. Croix, USVI.

- o) Senior staff are expected to be on-call. Have sufficient staff /supplies to support operations on all islands.
- p) Encouraged to find the most efficient and cost-effective method to conduct warehouse operations for each location.
- q) Have the necessary personnel, equipment and telecommunications services to be able to deploy staff on-site within seven (7) business days of contract execution. Expected to have the facilities operational with trained staff, equipment, supplies, etc. within fifteen (15) days after contract execution.

Warehouse Management General Standards

- r) Conduct business in accordance with all applicable local and federal guidelines.
- s) Shall provide all personnel, equipment, tools, materials, vehicles, supervision, and other items and services necessary to perform all services, tasks, and functions for as defined in this Scope of Work (SOW).

Facilities Management

- t) Expected Hours of operation:
  - a. Normal, Monday - Friday from 7:00am to 4:00pm AST / 5 days a week
- u) Ensure staff are issued, and carry at all times, valid Employee key/ID cards.
- v) Ensure that staff is equipped with all the necessary safety equipment, including but not limited (hard hats, clothing, appropriate footwear, etc.).
- w) Responsible for cleaning and maintain of the premises.
- x) Responsible for the initiation and maintenance of utilities including but not limited to electricity, fuel, water and power.
- y) Maintain all records, documents, and associated papers provided and generated during the period of performance. Such documents become VIHFA property and will remain in place or provided to VIHFA upon contract termination or completion. During the period of performance, records, documents, and associated papers shall be available for review.
- z) Adhere to the applicable Occupational Safety and Health Act (OSHA) standards. Comply with all Federal, State and Territory laws and statutes concerning safety.
  - aa) Manage all work areas to ensure the safety of building occupants, employees, or visitors in, or near, the areas. The Contractor shall provide support to VIHFA to resolve facilities and infrastructure related safety issues.
  - bb) Provide timely and accurate advice and support to the customers/visitors of the facilities.
  - cc) Perform other related duties as assigned.

### Inventory Management

- dd) Manage, control and charge all material(s) disbursed to a specific project. It is the intent of VIHFA that the Contractor shall provide and manage all operational equipment inventory required for the performance of the contract.
- ee) Perform routine counts of inventory.
- ff) Track all intake and release of materials.
- gg) Organize and keep the inventory organized in an efficient manner to be able to easily locate and distribute the materials.
- hh) Responsible for any loss and/or shrinkage of inventory of which a penalty will be accessed.

### Equipment


- ii) Have and/or acquire the necessary equipment to efficiently manage the sites.
- jj) Operate and maintain the equipment used in a safe manner.
- kk) Shall have the ability to acquire/lease an electrical power generator.
- ll) Shall provide fuel for the generator and equipment.
- mm) Shall have on site a fork lift for dock-loading, warehouse and lumber yard operations.
- nn) Shall have sufficient employees to manage inventory control and equipment.

### Infrastructure

- oo) Shall maintain location site and perform any maintenance or repairs needed to keep the facilities operating efficiently and in good condition.

### Warehouse Management System (WMS)

- pp) Expected to maintain an accurate account of the quantity, quality, price, location etc. of the inventory whether in the facility or in transit.
- qq) System shall be accessible by VIHFA for approximately 5 users.
- rr) System shall have the following requirements:
  - a. Picking - fill the orders received, provide support for mobile scanners and other handhelds as well as the ability to generate complete lists and packing slips as orders are created and designed.
  - b. Receiving - ability to receive and add both scheduled and unscheduled deliveries to warehouse and inventory counts. Also, include some returns management, quality assurance tools, and the ability to re-number or breakdown goods that are received in one quantity but shipped in another.
  - c. Counting - Accurately track all inventory across every stage and warehouse location with the WMS' counting feature. Counting systems should link up to

picking and receiving activities to maintain an accurate count and provide real-time data on your inventory. Offer cycle counting so that the system counts a few products each business day throughout the year to verify that inventory levels are accurate.

- d. Tracking – Ability to have lot and serial number tracking to allow/maintain control of inventory fulfillment.
- e. Storage and inventory management - Able to process delivered goods and the ability to allocate warehouse space to them.
- f. Warehouse control and management - System that responds to needs and orders as they happen, ability to track goods as stock is relocated in the warehouse.
- g. Group or wave planning – Ability to create custom picking strategies to meet current demand and adjust when orders or priorities change.

## 2. TERM:

This Contract shall be for a period of three (3) years or until all materials have been depleted, whichever comes first, subject to VIHFA's option to extend the term of the contract for a similar term subject to satisfactory performance. The contract term begins on or about 1st day of February, 2021 or the date on which the last Party has signed the Contract, whichever is later, and shall end on or about 31st day of January 2023 or when all the building materials have been dispensed, whichever is later.

## 3. COMPENSATION:

- (a) VIHFA, in consideration of satisfactory performance of the services described above, shall pay the Contractor as compensation for the services rendered under this contract an amount not to exceed Two Million Nine Hundred Ninety-Three Thousand and Five Hundred Dollars and 00/100 (\$2,993,500.00). Contractor shall submit invoices for work performed that conformed to the Project Schedule as outlined in Appendix B. Contractor shall submit monthly invoices to VIHFA for payment.
- (b) VIHFA's performance and obligation to pay under this Contract is contingent upon the availability of applicable disaster recovery funds. VIHFA shall be the final authority as to the availability of funds for this Contract and as to what constitutes "applicable funding" to complete this Contract. If any such funds are not made available for the Contract purpose, such event will not constitute a default on VIHFA. VIHFA will notify Contractor in writing at the earliest possible time if funds are not appropriated or available. The cost for services rendered under this Contract to be paid is not eligible for reimbursement from any other funding source.
- (c) It is expressly understood and agreed that in no event shall the amounts to be paid by the VIHFA to the Contractor under this Contract exceed the rates and conditions made a part of this Contract unless expressly agreed to in writing.

## 4. REPRESENTATIONS, WARRANTIES, AND COVENANTS BY CONTRACTOR:

The Contractor represents, warrants, and covenants as follows:

- (a) Contractor is duly organized and existing and authorized, qualified and licensed to do business in the United States Virgin Islands.
- (b) Contractor will, during the term of this Contract, remain engaged in the business of warehouse management services and remain in good standing and qualified to do business under the laws of the Territory, including maintenance at all times of a valid V.I. business license.
- (c) Contractor will not cease doing business, dissolve or otherwise dispose of all or substantially all of Contractor's assets and will not voluntarily consolidate with or merge into any other entity or permit one or more other entities to consolidate with or merge into Contractor.
- (d) Contractor has the power to execute, deliver and perform, and enter into the transactions contemplated by this Agreement, and has duly authorized the execution, delivery, and performance of this Agreement.
- (e) The execution and delivery of this Agreement, the consummation of the transaction contemplated hereby and the fulfillment or compliance with the terms and conditions of this Agreement do not and will not conflict with or result in a breach of any of the terms, conditions, or provisions of any legal restrictions or any agreement or instrument to which the Contractor is now a party or by which Contractor is bound or constitute a default under any of the foregoing.
- (f) No information, statement, or report furnished in writing by the Contractor in connection with the negotiation of, or performance under, this Agreement and the consummation of the transactions contemplated hereby, contains any material misstatement of fact or omits to state a material fact that would make the information, statement or report misleading.
- (g) That Contractor has obtained all the applicable licenses or permits, temporary or otherwise, as required by Title 27 of the Virgin Islands Code; and familiarized itself with the applicable provisions of Title 27 of the Virgin Islands Code pertaining to professions and occupations.


**5. CONTRACTOR RESPONSIBILITY:**


Contractor shall supervise and direct the work of its employees and subcontractors. Contractor agrees to maintain the professional standards applicable to its profession.

Contractor shall be responsible for its performance and that of its Subcontractors and Vendors.

Unless otherwise specified in this Contract, the Contractor will provide for and/or pay for all labor, materials, equipment, tools, machinery, transportation, and other goods, facilities, and services necessary for the proper execution and completion of the work within its scope.

**6. PAYMENT PROCESS:**

- a. Invoices shall be submitted on a monthly basis.
- b. Compensation shall be invoiced outlined in *Appendix A*. Full or partial payment will be made upon satisfactory completion of each invoice as accepted by the Project Manager. VIHFA will notify Contractor of any disputed charges within fifteen (15) days.
- c. Indemnification: Should the Contractor, after receipt of payment of invoices from the VIHFA fail to pay in a timely manner all persons who have fulfilled their obligations to perform labor and/or furnish materials in the prosecution of the work provided for herein, including by way of example Contractor's employees, subcontractors and furnishers of materials, machinery, equipment and fixtures, then Contractor agrees to indemnify VIHFA for said payment(s). Timely payments from Contractor to its Subcontractors and Vendors shall mean within three (3) business days of receiving payment from VIHFA.

#### 7. AMENDMENTS:

The VIHFA may at any time with written notice to the Contractor, request changes within the scope of services of this Contract. Such changes may include modifications, additions or expansion of the contracted services. VIHFA may also amend this Contract to conform with federal, state, or local governmental guidelines, policies, and available funding amounts, or for other reasons.

The Contractor may submit to the VIHFA a request for a change in the scope of work under this Contract. The Contractor will prepare a detailed written description of the change request and a proposed price of making such change. If VIHFA does not agree with the need for the change or with its price, the VIHFA can decline its acceptance with no cost obligation incurred. If the VIHFA agrees to the change, the VIHFA will negotiate with the Contractor and agree to a firm fixed price for the change. The Contractor will not be authorized to proceed until a properly executed amendment is in place.

Amendments to this Contract must be in writing and must be signed by a duly authorized representative of the parties to this Contract. Such amendments shall not invalidate this Contract, nor relieve or release the parties from their obligations under this Contract.

Notwithstanding the preceding, the Project Managers specified in Paragraph 6 and VIHFA may approve extensions to Deliverable Due Dates within the confines of the Performance Period.

#### 8. PROFESSIONAL STANDARDS:

The Contractor will complete all work in accordance with standard practices in the warehouse management industry and the work shall conform with any and all law and regulations which apply to the work being performed, whether or not explicitly covered in the Contract. Contractor warrants that the final product of Contractor's work shall be fit for the purposes for which it is intended.

**9. ASSIGNMENT:**

The Contractor shall not sub-contract or assign any part of the services under this contract without the prior written approval of VIHFA.

**10. NON-DISCRIMINATION:**

The Contractor shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. Such actions will include but shall not be limited to the following: employment upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.

**11. RETENTION OF RECORDS:**

All records shall be retained for a minimum of three (3) years from the termination or expiration of this Contract, unless notified in writing to extend the retention period. Records shall be made available, without charge, for review within ten (10) days of a request by the VIHFA.

**12. NON-DISCLOSURE:**

Except for disclosure to the VIHFA or its representatives, the reports, work papers and records, including information and data prepared or assembled by the Contractor under this Contract, shall be held confidential by the Contractor and shall not be made available or otherwise disclosed to any third party without the prior written approval of the VIHFA unless required to disclose information by order of a court of competent jurisdiction or other administrative authority.

**13. TERMINATION:**

**A. Termination/Suspension for Cause**

Notwithstanding any other provision of this Contract, the VIHFA may, after giving sixty (60) day prior written notice specifying the effective date, may suspend or terminate this Contract in whole or in part if Contractor materially fails to comply with any material term of this contract, which shall include, but not be limited, to the following:

- i. The violation of any of the material terms or conditions of this Contract.
- ii. The making of any material misrepresentation by the Contractor in the furnishing of any information to the VIHFA.
- iii. Repeated failure to comply with any of the rules, regulations or provisions referred to herein, or such statutes, regulations, executive orders, and guidelines, policies or directives as may be applicable at any time;

- iv. Failure, due to Contractor's negligence or willful misconduct, of Contractor to fulfill in a timely and proper manner the obligations under this Contract;
- v. Continual submission by Contractor of reports to the GVI, VIHFA or HUD, or their auditors, reports that are incorrect or incomplete in any material respect, provided Contractor is given notice of said failure and fails to correct the same within a reasonable amount of time; or
- vi. Improper use of funds as provided for under this Contract.
- vii. If, through any cause set forth above, Contractor shall otherwise fail to fulfill its obligations under this Contract in a timely and proper manner, or if Contractor shall violate any of the material covenants or stipulations of this Contract, the VIHFA shall thereupon have the right to terminate this Contract by giving written notice to Contractor of such termination and specifying the effective date thereof, at least thirty (30) days prior to the effective date of said termination. Contractor shall be paid for all authorized Services properly performed prior to termination.

If the VIHFA does not issue a payment of an invoice, through no fault of the Contractor, within fifteen (15) days after the date established in the Contract, then the Contractor may, upon three additional days' notice to VIHFA, suspend or stop the Work until payment of the amount owing has been received.

#### **B. Termination for Convenience**

VIHFA may terminate this Contract at any time by giving at least sixty (60) days prior written notice to the other Party. Contractor shall be entitled to payment for Services performed up to the date of termination contained within the notice, to the extent that the Services have been satisfactorily performed and are otherwise reimbursable under the terms of this Contract plus reasonable termination and demobilization costs incurred.

#### **C. Termination Due to Unavailable Funding**

**The continuation of this Contract is contingent upon the appropriation and release of disaster recovery funds to fulfill the requirements of this Contract. Failure of the appropriate authorities to approve and provide an adequate budget to the VIHFA for fulfillment of the Contract terms shall constitute reason for termination for convenience of the Contract by either Party. Contractor shall be paid for all authorized Services properly performed prior to Termination plus reasonable termination and demobilization costs incurred.**

#### **14. PROCEDURE FOR TERMINATION:**

The VIHFA may terminate this Contract by notifying the Contractor in writing at least sixty (60) days before the date upon which termination shall be effective. Upon termination and the effective date thereof, the Contractor shall utilize the time that reasonably may be required for the purpose

of closing work hereunder. All charges incurred shall be paid by the VIHFA upon submission of a final invoice by the Contractor.

**15. FORCE MAJEURE:**

The Contractor shall not be held responsible for delay or default caused by fire, riot, acts of God, wind storms, tsunamis, pandemics, hurricanes, or war, if the event is beyond the Contractor's reasonable control and the Contractor gives notice to the VIHFA immediately upon occurrence of the event causing the delay or default or which is reasonably expected to cause a delay or default. The Parties shall use reasonable efforts to eliminate or minimize the effect of such events on their respective duties under the Contract. Contractor may be entitled to an equitable adjustment in schedules and unit prices in the foregoing circumstances. If the act of God or force majeure, or the resulting impacts, continues for more than ninety (90) days that makes continued operations unfeasible; either party may terminate this Contract by giving the other party a further thirty (30) days written notice.

**16. INSURANCE:**


The Contractor represents and warrants that Contractor carries professional liability insurance in the amount usual and customary for warehouse management businesses of similar size, subject to normal deductibles, and covenants that Contractor will maintain such coverage as provided in the during the term of this Contract. Contractor shall also secure Liability insurance covering acts, errors or omissions arising out of, or failure to render, professional services related to the Services under this Agreement. The Contractor's professional liability insurance policy shall name the VIHFA as an "Additional Insured". Evidence of public liability insurance shall be delivered to VIHFA within ten (10) working days after the award.


Upon failure of the Contractor to furnish, deliver and maintain such insurance, this contract, at the election of the VIHFA may be suspended, discontinued or terminated. Failure of the Contractor to purchase and/or maintain any required insurance shall not relieve the Contractor from any liability or indemnification under the contract.

Contractor shall include all Subcontractors as insureds under its policies and shall be responsible for verifying and maintaining the certificates provided by each Subcontractor. Subcontractors shall be subject to all of the requirements contained herein. VIHFA reserves the right to request copies of Subcontractor's certificates at any time.

**17. LIABILITY FOR LOSS OR DAMAGE GOODS:**

Contractor should notify VIHFA within twenty-four (24) hours of any loss, theft, or damage of materials. Contractor shall have the responsibility to investigate the cause and extent of loss/theft/damage and provide VIHFA and AECOM with a written report (Loss Report) within five (5) business days after learning of the loss. The Loss Report will include the quantity and type of material that was subject to loss and should include a statement whether the Contractor believes it bears any financial liability for the loss. Notwithstanding the above, the Contractor shall be liable for one hundred percent (100%) of the replacement cost of any materials lost, damaged or destroyed within the facilities, to the extent caused by the negligence, gross negligence

or willful misconduct of Contractor, its employees or agents. Contractor will pay all undisputed amounts to AECOM and provide VIHFA written notice and verification of payment.

**18. INDEMNIFICATION:**

The Contractor shall indemnify, defend, and hold harmless VIHFA, its property, consultants, employees, and the funding agency harmless from and against all claims, damages, losses, and expenses, direct, indirect or consequential, arising out of or resulting from the Contractor's Work, or otherwise caused in whole or in part by any negligent act or omission of the Contractor, its subcontractor(s), any person or organization directly or indirectly employed by them to perform or furnish any of the Work or anyone for whose acts any of them may be liable, regardless of the negligence of such party.

**19. FALSE CLAIMS:**

The Contractor warrants that it shall not, with respect to this Contract, make or present any knowingly false claim upon or against VIHFA. The Contractor acknowledges that making such a false, fictitious, or fraudulent claim is an offense under the Virgin Islands law.

**20. CONFLICT OF INTEREST:**

The Contractor covenants that it has no interest and will not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance of services required to perform under this Contract.

**21. WARRANTY OF NON-SOLICITATION:**

The Contractor expressly warrants that it has not employed any person to solicit or obtain this contract on its behalf, or cause or procure the same to be obtained upon compensation in any way, contingent, in whole or in part, upon such procurement, and that it has not paid, or promised or agreed to pay to any person, in consideration of such procurement, or in compensation for services in connection therewith, any brokerage, commission, or percentage upon the amount receivable by it hereunder; and that it has not, in estimating the contract price demand, included any sum by reason of such brokerage, commission or percentage, and that all monies payable to it hereunder are free from obligation to any other person for services rendered, supposed to have been rendered, in the procurement of this contract. Breach of this warranty shall give VIHFA the right to terminate this Contract or, in its discretion, to deduct from the Contract Cost or consideration the amount of such commission, percentage, brokerage or contingent fees.

**22. INDEPENDENT CONTRACTOR:**

The Contractor shall perform this Contract as an independent contractor and nothing herein contained shall be construed to be inconsistent with this relationship or status. The Contractor shall be responsible for the supervision of Contractor's employees, subcontractors, and authorized representatives, if any. All workers must be competent and skilled in their work.

**23. LIABILITY OF OTHERS:**

Nothing in this Contract shall be contained to impose any liability upon VIHFA, or to persons, firms, associations, or corporations engaged by the Contractor as servants, agents, independent contractors, or in any other capacity whatsoever, or to make VIHFA liable to any such persons, firms, associations or corporation for the acts, omissions, responsibilities, obligations and taxes of Contractor of whatever nature, including but not limited to unemployment insurance and social security taxes for the Contractor, its servants, agents or independent contractors.

**24. NOTICE:**

Any notices required or permits to be given under this Contract shall be deemed sufficiently given or served if sent by certified mail, return receipt requested to the parties at the following addresses:

- c) Provide VIHFA, for review and approval, with its Safety Plan for both Warehouses within fifteen (15) business days after contract execution.
- d) Provide VIHFA, for review and approval, with a Transition Plan outlining demobilization of equipment, any storage containers on site, identifying close-out activities and reports, and final inventory and accounting reconciliation within 120 business days after contract execution.
- e) Provide VIHFA, for review and approval, with a Validation Report of Inventory on Hand within fifteen (15) business days receipt of VIHFA's Inventory Listing; notwithstanding receipt of Inventory Listing from VIHFA; a Final Inventory Listing, inclusive of a damage material count, should be available within thirty (30) calendar days from contract execution. The Final Inventory Listing will be attached as an addendum to this contract.
- f) Provide VIHFA, for review and approval, an Emergency Plan within seven (7) business days of contract execution that outlines how inventory will be stored and secured during emergency situations (i.e. hurricanes, etc). The Emergency Plan will be added as an Addendum to this contract within thirty (30) days from contract execution.

### **2) Operational Services:**

- a) Develop a plan for review and approval by VIHFA that covers how materials will be processed, disbursed and recorded within seven (7) business days of contract execution; inclusive of identifying the inventory management system.
- b) Establish a system, for review and approval by VIHFA, that that can collect payments and manage inventory to produce weekly reports for VIHFA, per item (i) below.

As part of the process, no material can move from the site without doing a damage inspection and filling out a damage report form.

- e) VIHFA reserves the right at least once per quarter (in a calendar year), upon five (5) business days written notice to Contractor, to visit the facilities for the purpose of conducting a physical inventory count of materials; site inspections; and to conduct any other inspections and/or audit of Contractor's operations.
- f) Within 30 days of contract execution, Contractor should provide an initial fully physical inventory count for review and approval to both VIHFA and AECOM.
- g) Contractor should complete a full physical inventory count to ensure every inventory item is counted at least once every three (3) months per calendar year and provide a reconciliation written report against its system inventory report. These reports are to be provided to VIHFA.
- h) Contractor should complete periodic cycle counts once a month and provide a written report to VIHFA.
- i) Contractor should provide VIHFA a weekly system inventory and sales report by the 5<sup>th</sup> day of the following month.

The Contractor/Subcontractor shall comply with the provisions of Section 109 of the Housing and Community Development Act of 1974. Part 215 and 24 C.F.R. § 85.36 (or 84.42, if applicable)). The Contractor/Subcontractor shall explain the actual or potential conflict in writing in sufficient detail so that the Territory is able to assess such actual or potential conflict. The Contractor/Subcontractor shall provide VIHFA any additional information necessary for VIHFA to fully assess and address such actual or potential conflict of interest. The Contractor/Subcontractor shall accept any reasonable conflict mitigation strategy employed by VIHFA, including but not limited to the use of an independent subcontractor(s) to perform the portion of work that gives rise to the actual or potential conflict.

16. SUBCONTRACTING

19. COPELAND “ANTI-KICKBACK” ACT (Applicable to all construction or repair contracts)

These policies and procedures ensure that Federal dollars are spent fairly and encourage open competition at the best level of service and price. Standards for procurement of supplies, equipment, construction, engineering, architectural, consulting, and other professional services are outlined in Title 31, Chapter 23, Sections 231-251q or the Virgin Islands Code and Title 31, Chapter 23 of the Virgin Islands Regulations.

34. Change Orders to Contracts


Change orders are issued when the initial agreed upon pricing or work to be completed requires modification. First, the contractor must complete a Change Order Request Form. This form and supporting documentation must be delivered to the Project Manager for review. Each change order must have a cost analysis. Once the Project Manager approves the change order, it is returned to the contractor for execution. Change orders are only invoiced on the final draw and categorized as "change order." The amount listed on the invoice must match the previously approved amount and must be cost reasonable. The Project Manager is responsible for verifying cost reasonableness. Verification documentation for cost reasonableness becomes an attachment to the change order.

35. Environmental Review

Every project undertaken with Federal funds, and all activities related to that project, is subject to the provisions of the National Environmental Policy Act of 1969 (NEPA), as well as to the HUD environmental review regulations at 24 C.F.R. § Part 58- ENVIRONMENTAL REVIEW PROCEDURES FOR ENTITIES ASSUMING HUD ENVIRONMENTAL RESPONSIBILITIES. The primary purpose of this Act is to protect and enhance the quality of our natural environment. The HUD environmental review process must be completed before any Federal funds can be accessed for program-eligible activities.

The primary objectives of the HUD environmental review are to identify specific environmental factors that may be encountered at potential project sites, and to develop procedures to ensure compliance with regulations pertaining to these factors. The HUD environmental review is designed to produce program-specific environmental review procedures in a program that can vary greatly in terms of scope of work.

36. Lead Based Paint

All housing units assisted using CDBG-DR funds must comply with the regulations regarding lead-based paint found at 24 C.F.R. § Part 35- LEAD-BASED PAINT POISONING PREVENTION IN CERTAIN RESIDENTIAL STRUCTURES.

37. Environmental Review Record

The Environmental Officer is responsible for maintaining a written record of the environmental review process. The ERR for all programs contains all the governmental review documents, public notices and written determinations or environmental findings required by 24 C.F.R. § Part 58- ENVIRONMENTAL REVIEW PROCEDURES FOR ENTITIES ASSUMING HUD ENVIRONMENTAL RESPONSIBILITIES as evidence of review, decision making and actions pertaining to a project of a recipient.

38. Flood Insurance Requirements

Grantees and subrecipients of Federal funding must ensure that procedures and mechanisms are put into place to monitor compliance with all flood insurance requirements as found in the Flood Disaster Protection Act of 1973, 24 C.F.R. § 570.605- NATIONAL FLOOD INSURANCE PROGRAM and 24 C.F.R. § 570.202- ELIGIBLE REHABILITATION AND PRESERVATION ACTIVITIES.

39. Duplication of Benefits

CDBG-DR funding intends to address the unmet needs of a community. The funds are supplemental to primary forms of assistance, including private insurance and FEMA funds. To avoid duplicative assistance and potential de-obligation of funding, subrecipient must utilize all possible funding sources before applying CDBG-DR dollars to a project. CDBG-DR programs are typically implemented after temporary disaster assistance programs, such as FEMA Individual Assistance which are not intended to make someone whole.

The Stafford Disaster Relief and Emergency Assistance Act (Stafford Act), as amended, 42 U.S.C. §5121 et seq., established the requirements for Duplication of Benefits (DOB) analysis.

40. Anti-Fraud, Waste and Abuse Checks

The Anti-Fraud, Waste and Abuse (AFWA) check is designed to identify discrepancies and risk-relevant issues in Applicant-provided information that may be indicative of fraud, waste, and/or abuse.

41. Affirmatively Furthering Fair Housing

The Fair Housing Act of 1968, as amended, 42 U.S.C. §3601, et seq., dictates that grantees are required to administer all programs and activities related to housing and urban development in a manner to affirmatively further the policies of the Fair Housing Act. Per the regulations of 24 C.F.R. § 570.601 and in accordance with Section 104(b)(2) of the Housing and Community Development Act of 1974, as amended, 42 U.S.C. §5301 et seq., for each community receiving a grant under Subpart D of this part, the certification that the grantee will affirmatively further fair housing shall specifically require the grantee to take meaningful actions to further the goals identified in the grantee's Assessment of Fair Housing (AFH) plan, conducted in accordance with the requirements of 24 C.F.R. § §§5.150-5.180 (Affirmatively Furthering Fair Housing) and take no action that is materially inconsistent with its obligation to affirmatively further fair housing.

42. Drug Free Workplace

The Drug-Free Workplace Act of 1988, as amended, 41 U.S.C. §81, as implemented by 24 C.F.R. § Part 24 Subpart F, §§983.251-983.262, requires that any grantee other than an individual must certify that it will provide a drug-free workplace. Any grantee found in violation of the requirements of this act may be subject to suspension of payments under the grant, suspension or termination of the grant or suspension or debarment of the grantee. VIHFA guarantees compliance with this Act.

43. Timely Distribution of Funds

The Supplemental Appropriations for Disaster Relief Requirements, 2017 (Pub. L. 115-56), approved September 8, 2017 (Appropriations Act), as amended, requires that funds provided under the Act be expended within two (2) years of the date that HUD obligates funds to a grantee unless otherwise authorized via waiver of this requirement by the Office of Management and Budget (OMB). The OMB waived the two (2) year expenditure requirement under 83 FR 40314; however, the provision to expend one hundred percent (100%) of the total allocation of CDBG-DR funds on eligible activities within six (6) years of HUD's initial obligation of funds remains in effect. The six (6) year expenditure period commences with the initial obligation of funds provided under 83 FR 5844. Additionally, per 83 FR 5844, the provisions at 24 C.F.R. § 570.494 and 24 C.F.R. § 570.902, regarding timely distribution and expenditure of funds, are waived and an alternative requirement was established.

Furthermore, consistent with 31 U.S.C §1555 and OMB Circular No. A-11 (2017), if the Secretary of HUD or the President of the United States determines that the purposes for which the appropriation was made have been carried out and no disbursement has been made against the appropriation for two (2) consecutive fiscal years, any remaining unobligated balance shall be canceled and will be made unavailable for obligation or expenditure for any purpose.

44. Property Management and Distribution

Regulations governing property management and distribution of real property, equipment, financial obligations and return of un-obligated cash post program closeout can be found in 24 C.F.R. § 570.506, 2 C.F.R. § 200.310, 2 C.F.R. § 200.343 and 2 C.F.R. § 200.344(b). The standards of 24 C.F.R. § 570.506 apply to any real property under a CDBG award recipient's control acquired or improved in whole or in part with CDBG-DR funds in excess of the simplified acquisition threshold, which is \$250,000.00. The recipient may not change the use or planned use of the property without proper notification to affected citizens and allowable time for comment by them. If the property is not a building for general government conduct, the use of the property may be changed with citizen approval if it either meets one of the national objectives as defined in 24 C.F.R. § 570.208 or if not, the recipient may either retain or dispose of the property for the changed use if the recipient's CDBG-DR program is reimbursed in the amount of the current fair market value of the property, less any portion of the value attributable to expenditures of non-CDBG-DR funds for acquisition of, and improvements to, the property. Following such reimbursement, the property will no longer be subject to any CDBG requirements.

45. Limited English Proficiency

Executive Order No. 13166, signed on August 11, 2000, requires programs, subrecipients, contractors, subcontractors, and/or developers funded in whole or in part with CDBG-DR financial assistance to ensure fair and meaningful access to programs and services for families and individuals with Limited English Proficiency (LEP) and/or deaf/hard of hearing. Fair access is ensured through the implementation of a Language Assistance Plan (LAP), which includes non-English-based outreach, translation services of vital documents, free language assistance services, and staff training. Vital documents are defined as depending

on the importance of the program, information, encounter, or service involved, and the consequence to the LEP person if the information in question is not provided accurately or in a timely manner.

46. Personally Identifiable Information

In accordance with 2 C.F.R. § 200.303, regarding internal controls of a non-Federal entity, a grantee must guarantee the protection of all Personally Identifiable Information (PII) obtained. The program will enact necessary measures to ensure PII of all applicants is safeguarded as to avoid release of private information. If a contractor or employee should experience any loss or potential loss of PII, the program shall be notified immediately of the breach or potential breach.

47. Uniform Relocation Act

CDBG-DR funds are subject to the Uniform Relocation Assistance and Real Property Acquisition Act of 1970 (URA or Uniform Act), as amended. 49 C.F.R. § Part 24 requires relocation assistance for lower-income individuals displaced as a result of the demolition or conversion of a lower-income dwelling and requires one-for-one replacement of lower-income units demolished or converted to other uses.

48. Residential anti-displacement and relocation assistance plan. Per Section 104(d) of the Housing and Community Development Act of 1974 § 42.325

(a) Certification.

(1) As part of its consolidated plan under 24 CFR part 91, the recipient must certify that it has in effect and is following a residential anti-displacement and relocation assistance plan.

(2) A unit of general local government receiving funds from the Territory must certify to the Territory that it has in effect and is following a residential anti-displacement and relocation assistance plan, and that it will minimize displacement of persons as a result of assisted activities. The Territory may require the unit of general local government to follow the Territory's plan or permit it to develop its own plan. A unit of general local government that develops its own plan must adopt the plan and make it public.

(b) Plan contents.

(1) The plan shall indicate the steps that will be taken consistent with other goals and objectives of the program, as provided in parts 92 and 570 of this title, to minimize the displacement of families and individuals from their homes and neighborhoods as a result of any assisted activities.

(2) The plan shall provide for relocation assistance in accordance with § 42.350.

(3) The plan shall provide one-for-one replacement units to the extent required by § 42.375.

49. Complaints and Appeals

Citizen comments on VIHFA's published Action Plan, any substantial amendments to the Action Plan, performance reports and/or other issues related to the general administration of CDBG-DR funds are welcomed throughout the duration of the grant. The Citizen Participation Plan is posted as a stand-alone document at [www.vihfa.gov](http://www.vihfa.gov). 50. Monitoring

As per CDBG regulation, 24 C.F.R. § 570.501(b), grantees of CDBG-DR funds are responsible for carrying out their programs to meet compliance with CDBG Program, statutory and regulatory requirements, including monitoring their project administrators, contractors and subcontractors. As such, throughout the

application, planning, design, and implementation phase of the program, VIHFA will conduct internal monitoring of processes, procedures, policy, applications, planning, design, construction, and other applicable phases.

51. Procurement of Recovered Materials

A non-Federal entity that is a state agency or agency of a political subdivision of a state and its contractors must comply with section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act. The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 CFR part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition, where the purchase price of the item exceeds \$10,000 or the value of the quantity acquired during the preceding fiscal year exceeded \$10,000; procuring solid waste management services in a manner that maximizes energy and resource recovery; and establishing an affirmative procurement program for procurement of recovered materials identified in the EPA guidelines.
