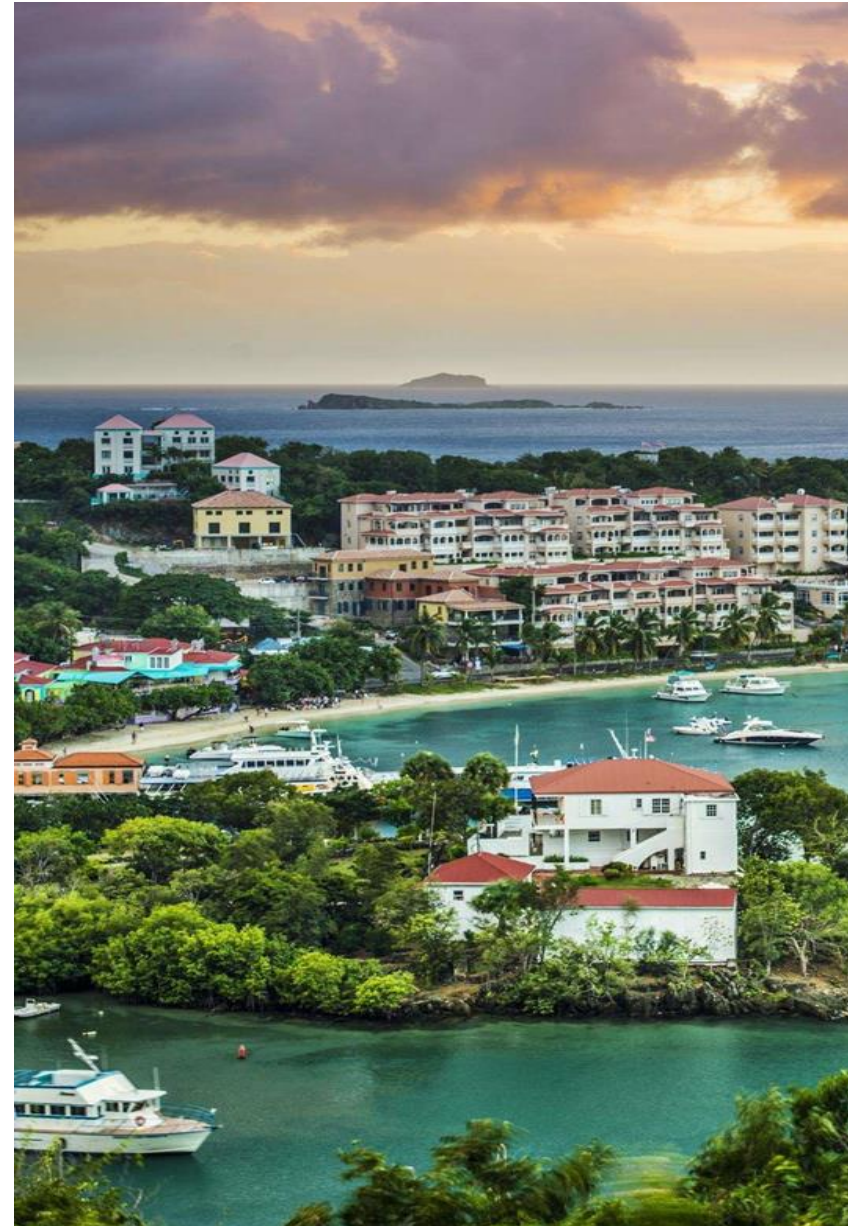

CDBG-MIT



Federal Register Notice (FRN) Vol. 84, No 169 published August 30, 2019, and FRN, Vol. 84, No. 175 published September 10, 2019.



US Department of Housing and Urban Development (HUD) allocated **\$774,188,000** in CDBG-MIT funds: (a) territorial mitigation and (b) resilience improvements.



Per FRN, VIHFA will conduct three (3) public hearings

Mitigation Activity, Definition

Activities that increase resilience to disasters and eliminate long-term risk of loss of life, injury, damage to and loss of property, and suffering and hardship by lessening the impact of future disasters.

** CDBG-MIT requirements are established in 84 FR 45838 (CDBG-MIT Main Notice) and 85 FR 2676.*

CDBG-MIT Activity Requirements

- 1** Meet the definition of a Mitigation Activity
- 2** Address current and future risks identified in the Territorial Hazard Mitigation Plan
- 3** CDBG-eligibility activities under Title I of the Housing and Community Development Act 1974 (HCDA)
- 4** Meet a HUD National Objective & a FEMA Community Lifeline

Additionally, the Multifamily New Construction Housing Program aims to address unmet housing needs by developing new rental units that align with modern standards, promoting secure, cost-effective housing options and incorporating resilient building practices to protect against future hazards.</p> |
