BACKGROUND

- The Department of Housing and Urban Development (HUD) has allocated \$1,075,489,884 in Community Development Block Grant – Disaster Recovery (CDBG-DR) funds to support the Virgin Islands recovery from Hurricanes Irma and Maria.
- VIHFA administers these funds in the territory.

CDBG-DR Funds

\$1,075,489,884 allocation by HUD

These funds can be used for five (5) categories of activities that <u>directly</u> respond to impacts from **Hurricanes Irma & Maria**.

Recovery Programs

Housing:

Assistance for homeowners and tenants of rental properties to achieve permanent sustainable housing solutions.

The programs support rehabilitation and reconstruction for homeowners and renters while making funding available for new construction of affordable and project-based subsidized housing.

Public Service and Special Needs Housing:

Public Services are activities undertaken to provide services to "at risk" populations counseling, and other related services for senior citizens and others. Fund rehabilitation and/or reconstruction of publicly owned facilities or buildings owned by non-profits or agencies that serve the public or the vulnerable populations to include persons with special needs.



Notes:

Infrastructure:

Addresses unmet needs related to damage from the storms; loss of critical services due to damaged public infrastructure.

The program supports the hardening of public facilities and networks, such as wastewater, portable water systems, solid waste, telecommunications, and public roads. When the Territory's infrastructure is made more resilient, critical services will be stabilized in the event of future disasters, creating a safer and more secure environment.

Economic Revitalization:

Addresses unmet needs in the local workforce, showcase the territory to the world, stabilize and support our infrastructure with improvements to our ports that will generate long standing economic growth for the Territory.



Why Is Reallocation Necessary?

>3% of the total disaster recovery allocations or change in designated beneficiaries.

The 4th Substantial Amendment highlights the following three (3) factors:

- Subject to HUD approval, the Office of Disaster Recovery (ODR) is named as a subrecipient managing Disaster Recovery (DR) projects
 - ODR will oversee CDBG-DR projects: execution and completion.
 - VIHFA shall retain grant oversight.
- 2. Addressing the remaining unmet need
- 3. The ability to expend funds within the remaining time allotted for the US Virgin Islands CDBG-DR grant cycle *(September 2026)*

HOUSING

Allocation increased \$15,355,926 for housing programs in this Amendment:

- Finalize repairs to storm-damaged housing and increase inventory of affordable single family and rental housing.
- Increased cost of construction due to labor and material. For eligible applicants pay costs for optional temporary relocation and storage.

Program cap (construction costs) remains at \$350/unit - HRRP and \$150/unit - RRRP.

 Currently 363 units of new or rehabilitated rental housing are under development, with all but 40 restricted to tenants at 80% or less of Area Median Income.





HOUSING

Removal of two (2) New Housing Infrastructure Construction (NHIC) developments and one (1) Public & Affordable Housing Development (PAHD) Rehabilitation project.

Funding remained in Housing and was allocated accordingly:

- Allocation of **\$46,130,853** to fund PAHD, shovel ready projects.
- Queen Louise project allocation was increased.
- Two phase construction single family unit development of 20 homes at Estate Fortuna (Wild Pineapple) on St. Thomas.
 - Phase 1 construction of 12 homes
 - Phase 2 construction of 8 homes including infrastructure



LOW-MODERATE INCOME BENEFIT

With the changes in allocations, the grants' Low-Moderate Income benefit remains at 70%.

Based on need, two programs **will extend benefits** to households between 81% and 120% of Area Median Income.

- New Housing Infrastructure Construction Program:
 Option 1 remains at 80% AMI
 Option 2 extends to 120% AMI
 Own a Lot Build A Home Program
- EnVIsion Homeowner Repair and Reconstruction Program

VIHFA continues to track LMI expenditures to ensure 70% LMI benefit requirement is met or exceeded.





PUBLIC SERVICE & SPECIAL NEEDS HOUSING

Special Needs Housing focus is repairs/replacements of damaged facilities that provide services to "at risk" populations – *i.e., children, the elderly, homeless persons, persons with disabilities, including victims of domestic violence.*

\$11,003,738 is allocated and committed to eligible projects for Special Needs Housing.

\$2,405,753 has been allocated for Public Services.

Funding provides:

- service to "at risk" populations to assist with recovery from the impacts of Hurricanes Irma and Maria.
- supplemental support to territorial agencies that will directly accelerate the speed of recovery.

Notice of Funding Availability (NOFA) was issued, six (6) applicants received notification of eligibility and award for Special Needs Housing and three (3) for Public Services.

NON-FEDERAL COST SHARE (Cost Share: FEMA 90% | Local (HUD) 10%)

Designed to assist state agencies, public entities, local non-profit organizations, and other eligible applicants by leveraging CDBG-DR funds with FEMA Public Assistance (FEMA PA) provided to the Virgin Islands to maximize, facilitate and ensure recovery.

DR funds are limited to covering the non-federal cost share match portion related to FEMA PA eligible project worksheets (PWs).

\$30,000,000 funding for Non-Federal Cost Share allocated back to the Program.



ECONOMIC REVITALIZATION



Funding for Economic Revitalization Program increased with the recategorization of Port Dredging Project (Charlotte Amalie Harbor) and Building Professional Workforce projects.

Neighborhood Revitalization Program funding remains the same. NOFA was issued and project submission were due in May 2023, the Program provides funding for:

- Grants and technical assistance to small businesses and microenterprises.
- Grants to improve facades, landscaping and amenities in commercial areas.



PLANNING & ADMINISTRATION



There was **no change** to the allocation for planning activities. **\$2,716,850** Planning Funds will be utilized for the SAI Project.

The administrative allocation remains at the maximum 5% of the total grant.
