The Department is approving the United States Virgin Islands Electrical Power System Enhancements and Improvements Action Plan – First Substantial Action Plan Amendment (APA) for the Community Development Block Grant Disaster Recovery (CDBG-DR) funds appropriated by the Further Additional Supplemental Appropriations for Disaster Relief Requirements Act of 2018 (Public Law 115-123), to address unmet needs from disasters that occurred in 2017. On June 22, 2021, the Department announced in the *Federal Register* Vol. 86 No. 117, 86 FR 32681, that USVI would receive \$67,653,000.00 for its electrical power system enhancements and improvements. This allocation is administered under grant number B-18-DE-78-0001.

On June 11, 2025, the Virgin Islands Housing and Finance Authority submitted its First Substantial APA addressing all *Federal Register Notice* requirements for approval. This APA revises the PR1 Program from project activities at the Estate Richmond Power Plant on St. Croix to Territory-wide initiatives for grid resiliency, adjusts the grant allocations budget to reflect the current unmet needs reducing the PR1 Program from 78% to 52.9%, and increases the allocation to PR2 from 10% to 32.1%. This APA creates a subcategory in PR2 in recognition of the expanding activity scopes to reflect the need in the direct community innovation applications.

The amendment also included adjustments and defines the activity delivery costs percentages to address the increase in programmatic costs, restoring the allowable percentage for planning and administration to address the increased costs in these areas.
